The Options will be included in the Fair packets. Option 2 will be modified to rank the fastest 5 times (have to be blue times). Unanimous decision!
- **c.** Hairy Horse Show Recap: Great turnout. 73 riders. Performance ran long because it was so well attended. For the most part, the show ran very smooth.
- **d.** Special Need Riders/Classes Updated: Hasn't appeared that the rider is in 4-H.
- **e.** Pre-Fair: Cara will run the performance portion of the show. Denise and Peggy will manage the gaming day of Pre-Fair.
- **f.** July Clinic Updates: Still planning on July 7-9th. Motion was made by Peggy and seconded by Cara F. to make the July Clinic a qualifying clinic for fair.

- a. Hairy Horse Show #2: Requesting to change the start time to 8:00 am. Office will open at 7:00. Suggestion was made to purchase \$20.00 grand and \$15.00 reserve high point prizes for the next HHS. Nichole would like someone to step up and be the Gaming Manager to help with course set up. Denise will help with the Gaming Manager.
- **b.** Miss Teen Rodeo: Mikayla Smith is having a Coronation Celebration/Fundraiser this Saturday at the Fairgrounds. Feb. 7th at 5:00. She is asking for clubs or individuals to donate silent auction items, auction desserts and volunteers to help with the evening.
- c. Ex. Committee Elections/By laws: Brian noted that offices are up for election every year. Brian will draft up an election schedule to vote in offices every other year.
