### VIII. Other/Old Business:

- **a.** Fair: no news
- **b.** Hairy Horse Show Series: Jan. 26<sup>th</sup>, Feb. 23<sup>rd</sup>, and March 30<sup>th</sup>. 41 riders attended the first show.
  - i. Safety issues: need to address side entrance and people walking through the staging area, more of an issue during gaming.
  - ii. Volunteers: need more volunteers, especially during gaming, we had to stop the show until more volunteers came down.
  - iii. High Point Awards: After discussion, it was motioned by Gwen C. and seconded by Grace P to award personalized sweatshirts to the high point winners. **Darcy P. will work with the printer on these**. Riders must be present at all 3 shows to be eligible.
  - iv. Ribbons: After discussion, it was motioned by Grace P. and seconded by Leslie T. to offer ribbons 1<sup>st</sup>-6<sup>th</sup> place at the show. Sponsors for the ribbons will be looked for. Thank you Wild at Heart for donating to this cause!
- c. Fair/Prefair Judges: Deb Hoines has been confirmed as our Fair performance judge and her contract is in the mail and **Denise S. is working on firming up the gaming judge.** Prefair judge will be Barb Aberlie out of Olympia. She will judge performance and gaming.
- **d.** Colt Training: Group met and will be finalizing the checklist to be met each year of a colt project. Checklist will include a pattern for the project (showmanship and/or riding). The colt project will not be a judged event, but more a demonstration of the process of the project. Youth will be awarded based on their demonstration of meeting the criterion for the age of their colt project.
- **e.** Animal Appeal document was passed by General Council. Youth will need to fill out a Horse Certificate on the horses they have successfully cliniced; see Gwen C. for more information.

- f. Taxes-update: Jill is working on this. She has until May to complete.
- **g.** Donated saddle: A community member donated an English saddle. If you know of any 4-Her in need, please let Brian know. Carol S. took it with her to check if any of her club could use it.

#### IX. New Business:

- a. Clayton C. confirmed with the fairgrounds that Horse Council needs to pay an additional 50.00 to rent the Cow arena for Prefair. He will book this for performance to be used for trail.
- **b.** Brian M. encouraged clubs to attend and to encourage club officers to attend the meetings. Horse Council loves input from the youth, decisions directly affect their project.
- **c.** A new equipment sign out will be in the storage locker to ensure ALL equipment is returned after shows.
- **d.** Thank you's were signed for our judges and for the generous donation of a chalker.
- e. Clinicians: Anyone interested in becoming a clinician for the schooling shows to clinic new riders, horses, and/horse-rider combos, please talk to Gwen C. (to be discussed further at the March meeting)
