### VIII. Other/Old Business:

- a. Hairy Horse Show #2 updates and debrief: We had 44 participants. More volunteers are needed to make the shows run smooth. Leaders please encourage your clubs to send volunteers to the March 30<sup>th</sup> show. These shows are our fundraisers for Pre-Fair, Fair, and end of the year awards.
- **b.** Taxes: see financial report above.
- **c.** Donated saddle: Carol S. is still working finding it a home.
- d. Clinicians: Anyone interested in becoming a clinician for the schooling shows to clinic new riders, horses, and/horse-rider combos, please talk to Gwen C. Must be able to judge a rider/horse combination as safe to show at fair in performance, gaming, and/or driving. Must be able and willing to articulate to leader, parent and rider why they did not pass the clinic. It is a very daunting task to tell a rider they did not pass the last clinic and they cannot go to fair. Must be very familiar with the PNW guide and our county rules. Must be fair and impartial. Thank you Kathy B. for volunteering to become a clinician.
- e. It was moved by Gwen C. and seconded by Jill S. to allow the Horse Council to rent the Cow Arena for \$50.00 for Saturday of Pre-Fair. Motioned passed and Clayton C. will book this for the Performance day of Pre-Fair.
- f. Brian will not be at the next Horse Council Meeting. Clayton will run the meeting.

### IX. New Business:

**a.** Rule Consistency with other shows, Karissa W. Karissa asked about the gate rule that was implemented at the gaming portion of the Hairy Horse. The gate needed to be closed prior to the judge granting the course to the rider.

Show managers addressed the issue. Gwen C. referred to the 4-H manuals and the safety standards outlined in the manual. Discussion ensued regarding the safety of riders, horses and gate keepers.

Solutions were presented by the attendees:

- 1.) Prior to the gaming show, have the judge meet with the riders to remind them of the safety rules of 4-H, set clear expectations and answer any questions.
- 2.) Add rules to the back of the premium to educate our youth. Not all rules can be included so a disclaimer would be present to refer to the 4-H manual for ALL rules.
- 3.) Encourage riders to focus on the judge and his/her flag so they know if they have been granted the course or not.
- 4.) Have more than one person on the gate due to the fact it is so heavy.

  Madison W. volunteered to attend the March 13<sup>th</sup> meeting of the Fair Board to request a lighter gate or repair the current gate so it is more manageable.
- 5.) Leaders present the rules and safety expectations at a club meeting so riders know the rules.
