- a. Treasurer Report & Annual Budget, Linda & Tracie
  - i. Review and discussion of proposed financial tools including income and expense forms, sample treasurers report form, account binders, and budget (attached).
  - ii. These decision-making tools are living documents that can be revised as needed through future dialogue. Tracie will send Linda a revised electronic version that incorporates discussed formatting changes.
- b. Camp Budget & Fees Increase, Rhonda
  - i. Discussion of proposed budget and camp registration fees (attached)

- ii. **Mary P. made the motion** to update camp registration fees to \$150 for youth who are enrolled in 4-H by April 1<sup>st</sup>. Registration fee of \$175 would apply to youth who are enrolled in 4-H after April 1<sup>st</sup> or anyone submitting camp registration after the first Friday in June (June 2<sup>nd</sup> in 2017). **Linda W. seconded the motion, which passed.**
