- **c.** Clinicians: We now have 4 clinicians (Gwen C., Kathy B., Denise S., and Nichole W.) to sign off on clinic forms at future shows. Any others who are interested can contact Gwen C.
- **d.** Hairy Horse Show Updates: Suggestion was made to move the chain during performance to make the ring small and make the warm up area larger, especially on wet days when space is limited. Gate seemed to work better and run smoother. This was the biggest show of the series with the best volunteer turn out. Suggestion was made to have new riders/combos put green ribbon in horses' tails so others know to help more. There were still some major safety concerns...parents and leaders need to address these when they are happening and keep 4-H a positive learning environment. Leaders be sure to help youth know the Contest Guide Rules!

IX. New Business:

- a. Prefair: Dates are June 28th (Performance) and June 29th (Gaming). Gwen and Denise are the show managers. They are in need of a trail judge and a trail course design. Wendy B. will contact Joyce and design a course. It was motioned by Gwen C., seconded by Carol S. and passed by the group to pay the trail judge \$50.00. Wendy will need help setting this up in the Cow Arena Saturday of Prefair. Clayton C. will repair the bridge and make sure it's safe and functional for Prefair.
- **b.** Summer Clinic: Gwen is working on a couple different options to provide another opportunity to clinic in July. Option 1: a multi-day learning clinic in the outdoor arena at the Fairgrounds. Option 2: a one day learning clinic at Cedarville Arabians. More information will follow.
- **c.** Fair: Gwen is still waiting to hear from the Fair Board on a final decision to finish up the schedule.
- **d.** Horse Possession: Carol S. clarified that horses must be in possession by May 1st to show at the fair.
