- V. Financial Report
 - a. Tracie shared Treasurer's Report
 - i. Report is a work in progress but Tracie has done a terrific job so far
 - ii. Dan reported that Tracie will not be doing this task long-term, only working to bring all information up-to-date before passing on to Treasurer.
 - iii. Tracie has also put together a Resource Packet for the Treasurer, which she gave to Linda Waltenburg.

 - i. Connie has spoken with Denise, no planning yet as Denise was tied up with WASHET which just completed
 - ii. Dan reports that Mason County members have committed to participating in Breakfast tasks

- iii. Plan to budget for more food this year to avoid running out, which happened in 2016

 - 1. Will meet after tonight's meeting.
 - 2. Corree reports that Salad and meat are covered for the event

 - a. Panhandle
 - i. Rhonda passed around a list of Panhandle jobs that could be done by volunteers
 - 1. Hand tools only due to insurance & safety concerns, particularly for youth members
 - 2. Possible 2-day camp work party, could become an annual Spring Clean-Up event
 - ii. Fishing Derby June 4, 8am-11am
 - 1. Up to 15 years of age
 - 2. All who participate will receive a price
 - 3. No flyers yet but will be coming
 - 4. Will promote via radio
 - 5. Fish are contained in a netted area, when derby is completed remaining fish will be released into lake
 - iii. 2 Open Positions At-large on Panhandle Board
 - Hoping to attract persons to fill those positions who possess certain skills such as Social Media or Website usage & development, Financial or Marketing Skills
 - 2. Interested parties should submit resume to Panhandle Board
 - b. Grays Harbor Youth Livestock Auction
 - i. Nancy reports meeting was held
 - ii. Income from Auction \$148,241.65
 - iii. Nancy had report available for viewing
 - iv. Mandatory meeting is May 3, 5-6:30pm, as of 2 weeks ago, there have been 53 responses
 - v. Tagging will be May 20 and June 5
 - vi. Weigh-In is July 10
 - vii. Working on getting 2 verts for fair
 - 1. No animals will be allowed into barns until passing vet-check
 - 2. Fair vet decisions are final
 - 3. In the past, vet checks have been for superficial issues only
 - viii. Need to update Exhibitor handbook to 45 days of possession for Rabbits
 - 1. Connie asked why the GH Auction does not follow State Handbook
 - a. Nancy indicated that this had to do with weight limitations due to short growing time
 - b. Mary clarified that if the Auction would allow cross breed rabbits, there would be better chance of getting rabbits up to weight requirements for auction

ix. Need better communication between Superintendents and judges to make sure that the proper balance is found between Standard of Perfection, Ribbons & Marketability.
