- **a.** Hairy Horse Shows: 3 shows are confirmed. Gwen has volunteered to be the Gaming Manager and Gina C. will shadow. Nichole has the contracts for the fairgrounds, contracts include the bills for the HHS and pre-fair is free and she will pay for the insurance. \$20 prize limit for high point and \$15 for reserve high point awards.
- **b.** Gaming Superintendent: Still looking for a volunteer. This is an application process that has to be approved by the General Council.
- **c.** Showmanship: A short discussion took place regarding showmanship, to combine gaming and performance or leave them separate. Darcy motioned to leave showmanship as separate classes for the year. Gwen seconded and the motioned passed unanimously by the group.
- **d.** Herdsmanship: Short discussion took place regarding the herdsmanhip for fair. This is a club volunteer committee so anyone interested in making this better can volunteer their club to organize herdsmanship for fair.
- **e.** Erin Randall: There is money in an endowment in a 4-H foundation to make this a monetary award like it has been in the past. Cara has been in close contact with the family. Thank you for contacting the family and keeping this special award in place. The council will continue to generate ideas to make these awards meaningful and recipients will be encouraged to acknowledge these generous awards.

f. Record Books: Peggy has been in communication with Posse regarding the awards for the books. They would like to award these kids at the end of the year at the banquet or at the County level and they can present at the awards ceremony at fair.
