#### **GENERAL RULES: See Pacific Northwest Horse Contest Guide Reminders:**

\*4-H members may only share a horse in a separate age division if they share the same project horse on file.

\*\* Youth must be enrolled in 4-H horse project with a horse certificate on file by May 1, of current 4-H year, for the horse they wish to show at this event in order to be eligible for State Fair participation. All enrolled 4-H project members may show at this event.

Must be in good standing with Stevens County 4-H horse guidelines and requirements.

\*Please review the Pacific Northwest Horse Contest Guide (4-H manual) for all applicable rules for this show. It is the member's responsibility to know the rules of the show. (age of horse, rider, required/restricted tack and clothing) and any other rules for each class/discipline.

\*Dressage riders must provide a caller if they want one for their classes, we will not provide one, unless someone volunteers.

\*Classes may be moved around to accommodate time constraints.

\*4-H members must participate in showmanship. Late arrivals will not be allowed to show if they miss showmanship.

\*The Danish System will be used. Ribbons will be awarded to all participants based on their own merit

<u>PLEASE NOTE</u>: 4-H PACIFIC NORTHWEST CONTEST GUIDE takes precedence over all other manuals. The guidelines and rules within this publication are the guidelines and rules that Stevens County 4-H equine events will follow. USEF rules will prevail over the use of 4-H manuals for Dressage events.(http://4h.wsu.edu/projects/documents/2012PNWHorseGuide\_finalapproved.pdf)

It is the responsibility of all exhibitors to know the rules of this show. Please refer to the Pacific Northwest Contest Guide, for 4-H rules and regulations. (A copy will be available the day of the show for viewing. You must refer to this manual for the correct tack and attire to wear at this show. There will be a tack and attire check prior to the show and riding classes. Exhibitors not in compliance may be disqualified from a class or need to change to appropriate tack and attire. Please come prepared.

You must enrolled in the 4-H horse project and have a horse certificate on file by May 1 of current 4-H year..

Junior: age 8-10 Intermediate: 11-13 Senior: 14 and under 19

Show management reserves the right to refuse any entry of any exhibitor who has shown an objectionable attitude toward a given show or previous unsportsmanlike behavior at a show or to its management. Show management reserves the right to combine, cancel or split classes accepts entries for unfilled classes at regular fee, and to substitute or vary officials listed in the program list. Exhibitors will be advised if any changes are to be made. The judge has the option and is encouraged to ask for any reasonable additional work to aid in the placement of any class. The judges' decision is final! No person may enter the space set aside for the judge without permission of the ring steward. All entries must be in writing by the owner or agent. Parent or guardian must sign all entries of exhibitors under the age of 18 years old.

- \*\*NO RIDING DOUBLE
- \*\* ALL DOGS MUST BE ON LEASH
- \*\* HELMETS REQUIRED WHEN ON HORSE BACK BY ANYONE 18 YEARS AND UNDER

**In classes** where horses compete collectively, the gates will be closed **2 minutes** after the first horse has entered the ring. No horse is allowed to enter the ring once the gate is closed. Gate holds must be cleared with the management prior to the class.

**Exhibitors** must appear in the ring suitably attired with the correct number, clearly visible to the judge at all times when in competition. Entries with incorrect number or no number will be disqualified.

Stallions Not Allowed Unless, under 1 year of age and may be shown by Senior 4-H members and adults in accordance with 4-H policies. All stallions will maintain their space in the arena.

WSU Stevens County Extension, Burlington Ranch, members of the show committee and its' associates will not be responsible for any loss or damage or injury, by fire or otherwise, that may occur to any horse, or for any article of any kind that may be occasioned to any person, whomsoever, by any horse owned or exhibited by him and shall indemnify the above organization against all claims and demands, of any kind or nature that may grow out of injury occasioned by any horse or exhibited my them or arise from the negligence of the person in charge of any action from such horse. All horses will be entirely at the owner's risk.

**<u>AWARDS</u>**. All Classes will be judged by the Danish system and each exhibitor will be awarded a blue, red, or white ribbon. Grand and Reserve ribbons will be awarded to the top two blue placing exhibitors in each class.

High point buckles will be awarded to the overall highpoint Junior, Intermediate and Senior for the day. All classes count toward high point in each division, except Dressage training level test 3, and Dressage seat equitation. A reverse point system from highest to lowest points per class to all individuals will be used to calculate high point

\*All entries must be received by July 22<sup>nd</sup>, 2017

Refunds will be given only upon receipt of a veterinary certificate stating the nature of the disability and presented prior to the horses' first class. Refunds will be by check in the mail

#### **CLASS DESCRIPTIONS**

#### SHOWMANSHIP REQUIRED CLASS

Open to any breed. Horses and ponies are to be fitted and shown according to breed type. English or Western attire and equipment allowed. Showmanship: To demonstrate the ability to lead, turn, and move his or her animal as the judge directs. Judged 50% on showmanship and handling, 25% on grooming and cleanliness of animal, 25% on neatness and cleanliness of handler.

**BAREBACK EQUITATION** May be ridden in English or Western tack and attire. Exhibitors may be asked to perform any test listed in equitation. Western riders must sit the **jog** or intermediate gait. English riders must post the trot on the correct diagonal. No mount or dismount is allowed. Riders to be judged on hands and seat and the lope/canter shall always be on the right lead. Exhibitors will be asked to work both directions

of the ring at a walk, jog/trot, lope/canter, stop, reverse, back, and any other tests or patterns the judge deems necessary. CHAPS ARE NOT ALLOWED IN 4-H equitation classes.

**EQUITATION** (Stockseat Equitation and English (Hunt Seat ) Member and appointments Clothing, equipment, courtesy, poise.15% Seat and hands Seat, posture, head, legs, hands, balance, distribution of weight, aids..35%

Performance Standing, starting, walking, jogging or posting trot, figure-8 or equivalent at lope or canter from walk, stopping, turning, backing, general control.50%The horse should do what the rider asks with the least possible effort on the part of the rider and least amount of resistance from the horse. The member will be judged on correct posture, smooth gait transitions, and effective use of aids, with special emphasis on light hands. The performance of the horse is not to be considered more important than the methods used by the rider in obtaining the performance. The member, horse, and equipment may be inspected at any time during the contest. Members using unsafe equipment may be asked to leave the ring.

**TRAIL**: The trail class is an under-saddle mounted test of horse control and the rider's ability to guide the horse through a series of obstacles. The rider may show English or western. Each obstacle has a value of 10 and is scored according to how the rider maneuvers through the entire obstacle.

HALTER: : Class is judged on the conformation (bone structure, muscling, balance) of the horse.

**PLEASURE:** Western and English - A pleasure to ride. Contestants compete simultaneously, traveling around the perimeter of the arena. Horses are judged on functional correctness, quality of movement including consistency of their gaits, and attitude.

**Discipline Rail:** Western and English: This class will be offered at the state horse show as two separate classes in English and Western tack and attire. Disciplined Rail is an advanced class which tests the skills of both horse and rider, as they execute specific gaits, transitions and movements as requested by the judge. Following are some, but not all, of the items the judge may ask you to perform: 1. Transitions to and from any gait, such as trot to canter, hand gallop to halt, halt to canter, trot to counter canter, etc. You may also be asked to perform a gait for a specific number of steps or strides.
