## ACKNOWLEDGEMENT, DISCLAIMER & WAIVER FOR USE AT THE CLALLAM COUNTY FAIRGROUNDS

The undersigned represents as follows:

- 1. That he/she is over the age of 21 or is the parent or the guardian of a juvenile, and that said juvenile has the undersigned's permission to use the facilities at the Clallam County Fairgrounds, 1608 West 16<sup>th</sup> Street, Port Angeles, Washington. (See Chapter 6, Section 1, C.C.C.23.03.020 Definitions for "juvenile").
- 2. That he/she has had the opportunity to inspect all those facilities which they or the juvenile for whom they are signing will be using; and
- 3. That they have been informed that the use of Fairgrounds facilities is only by prior arrangement and with the specific permission of the Fairgrounds management, which permission may be revoked at any time without notice for any cause including, but not limited to:
  - (a) Failure to abide by posted requirements for, or restrictions on, the use of Fairgrounds facilities;
  - (b) The engagement of behavior deemed by Fair management to be dangerous, disruptive, destructive, or not representative of outlined goals;
  - (c) Failure to return any keys to facilities or the reproduction thereof;

- 4. A User fee in the amount of \$10.00 per person, per day, will be assessed for use of the arenas and payment is required prior to use. <u>Exceptions</u>: 4-H clubs, FFA members, and Junior Rodeo during their work days or pre-Fair.
