## Washington Pork Producers

Information regarding youth pork producers to pay a fee were emailed out through 4-H. Mark said that this has come up before but never targeting 4-H and FFA. He would look into it more. As of now, the auction committee would be required to charge .40 cents per \$100 value on animals sold at auction.

#### North Mason FFA

A letter was sent by advisor Michelle Carter asking permission that the NM FFA be allowed to participate in our auction this year. A motion was made by Carrie Thompson and second by Travis Harkness. Motion was carried. Stipulations: it is for this year only. Further discussion brought up concerns that other county chapters would want to join our fair.
