Chelan and Douglas County Guide for Demonstration Judges

Judge's Role

- Evaluate each demonstration.
- Give reasons for judging decisions.
- Encourage the presenter and give either oral or written suggestions for improvement.
- Select winners when appropriate.

Give the member up to five minutes to set up for his/her demonstration. This includes putting his/her poster up and arranging equipment.

Take a minute to introduce yourself and visit with the member to help him/her relax. When the member appears to be ready, *listen carefully to the demonstration*. Make check marks in the appropriate boxes on the judging sheet. The sections of the score sheet are explained below:

4-H Age Divisions

•Primary: Grades K-2 •Junior: Grades 3-5 •Intermediate: Grades 6-8 •Senior: Grades 9-12

Purpose of Demonstration

4-H members may speak on any topic of interest to them and select the "type" (informative, persuasive, motivational or entertaining) of presentation. What is the presentation to accomplish? Is it entertain? Stimulate? Convince? Help people learn? Show what a member knows? Or both? The member should decide on the response wanted by the audience and work toward that goal.

- Informative: Gives the audience information and facts on a subject.
- Persuasive: Persuades the audience that the speaker's opinion is best or sometimes used to change ways of thinking.
- Motivational: Encourages people to join an activity, program or take some kind of action.
- Entertaining: Entertains the audience but can be used to communicate a message.

Knowledge of Subject

Gathering information and researching the demonstration subject is one of the valuable purposes of the activity. Senior members are expected to do research for their speech and their talk should include factual information in addition to personal opinion or personal experience. Intermediate and Junior members are expected to do some research but not as much is expected. For primary members research will be much less. Effort should be made to use accurate and up to date material in all 4-H demonstrations.

Introduction

Each speaker is expected to greet his or her listeners, introduce themselves, give the title of their talk and explain why they picked this demo/presentation. The introduction does not need to be the very first words spoken because members are encouraged to start creatively with something like a question, challenge, statistic, stimulating visual, or comparisons.

Suitable Subject

Subject should fit the 4-H member's interests, experiences, knowledge and skills. It should be exciting, not dull; challenging, not routine, useful and interesting.

Douglas and Chelan County Leader's Councils

Judges, leaders, members and parents from Chelan and Douglas counties met on March 23, 2015 to discuss demonstrations. We started our discussion with a brainstorm session of why we like demonstrations. Next we moved to small groups to quickly brainstorm ways to improve demonstrations. As a large group, we pritiorized our ideas and made an action plan. Now, we have a collection of our ideas for you to consider:

Demonstration Committee Recommendations for 2015

Reworked Score Sheet

- Scores added to make judging quicker and simpler. Allows judges to pay attention and easily add scores at conclusion of presentation. Additional column or category of scores.
- Spot for time of presentation with explanation of points removed for going over or under specification.
- Explanation on back of score sheet for how to add scores and determine winners.
- · Wording clarifications in some categories.

Judges Guidelines

Explanation of each category on score sheet in order it appears on score sheet. Definitions/explanations come from our state publications EM4788 and EM4903E.

Fair Space for Demonstrations

Chelan County- 109 4-H members gave demonstrations at Demo Days 2014. 62 members qualified for State with their Demo. (15 were too young to qualify)

Douglas County- 16 members gave demonstrations at Demo Days 2014. 10 of those 4-H members qualified for State and one member was too young to qualify.

4-H members, community and the local fairs could benefit by providing stage space for some of the kids who qualified for State with their demonstrations. Each fair could provide an allotted amount of time (hour), we could fill the time with willing qualified 4-H members. Fairs get great entertainment and provide valuable practice space for our youth; Public gets a taste of 4-H and our success; 4-Hers get an opportunity to practice with a larger audience and prepare for state competition.

Judge Qualifications

Recommend to best of ability to limit leaders or parents as judges. It would be nice if we could all take the time to recruit a few people to judge. Committee would like each judge to receive a judges packet like the one given to you tonight in addition to a welcome/thanks letter.

Recommendation for 2016

Training

Video for leaders, judges and members. It is difficult for people to attend training but a video that could be watched on our own time explaining a demonstration and the score/judging could be helpful for all participants. Perhaps we could film some of this years demonstrators and judges to make a training video.

Scoring/Determining Winner

After the presenter is finished, look at the check marks in the columns on the score sheet. Use the numbers in the column you marked to add up a score for each row. Add all the points in the score column to get a total score.

Put your score and the other judge's score in the appropriate blanks at the bottom of the sheet and add them up. Divide the total by 2 to find the average score.

Compare the average score with the scores for blue, red and white ribbons. Mark the ribbon placing that correlates with the average score.

To determine a winner in a particular category, you choose the person with the highest overall score. However, if you have a tie for first place, then you and your fellow judge will need to consider which of the demonstrations with the highest scores you feel was the best. When you have a decision, add 1/2 point to that score and indicate "overall winner".
