Bi-County Horse Leader's Meeting Minutes December 11th

Linda moved to accept the secretary minutes with the clarification of the dates and the shows. Betsy seconded. Motion passed.

Joyce Neville voiced her concerns about having back to back performance and gaming shows. Lack of help in the evening and the long day being too long for the younger kids and the horses if doing all games.

Discussion pursued regarding the issue of performance and gaming showmanship requirements on the same day. It was agreed that the July 18th and August 1st show dates would include performance and gaming. There will be a gaming clinic and trail clinic along with the performance clinic on May 16th. The August 2nd show will be performance only and then Joyce will be scheduling another show at Mike Stokes.
