Vaughn Palmer has been the Vancouver Sun's provincial political columnist, based in Victoria, since 1984. He hosts Voice of B.C., an hour-long interview show on Shaw TV and also does commentaries on CKNW radio, based in Vancouver. For 22 years, he has done a weekly commentary on Canadian news on KUOW, the NPR radio station at the University of Washington. During that time he has covered eight premiers (and counting, judging from the latest opinion polls). Palmer attended the University of B.C. He also attended Stanford University on a journalism fellowship in 1982-83. He is a past winner of the Bruce Hutchison award for lifetime achievement from the Jack Webster Foundation and of the Hyman Solomon Award for excellence in public policy journalism from the Canadian Public Policy Forum.
