1. Call to Order - Dwight Hagihara

- 2. Approval of 8 July, 2011 Minutes Dwight Hagihara
- 3. Climate Action Plan update Marty O'Malley
 - a. The revised Climate Action Plan will be sent out for review. Any comments need to be sent back to Marty O'Malley by the 19th of August, so that a final version may be sent to DOE by the 31st. We are only responsible for WSU Pullman and the research/extension branches. Regional campuses will be responsible for reporting own numbers.
- 4. Stormwater construction ordinance Gene Patterson
 - a. Ordinance was adopted in January 2011 and only applies to planned projects. WSU and Pullman are regulated by the Dept. of Ecology's Eastern WA Phase II Municipal Stormwater Permit. Pullman is regulated as a Primary Permittee and WSU as a Secondary Permittee. The ordinance regulates sites that are at least 1 acre in size which are called Large Projects. It also regulates projects that are between 5000 sq. ft. up to 1 acre in size which are called Medium Projects, as well as smaller projects that have the potential to for significant amounts of sediment to migrate off-site. The Municipal Permit allows Primary and Secondary Permittees to enter into agreements that allow Primary Permittees to rely on Secondary Permittees to satisfy Primary Permittee requirements. Since WSU was already performing most of what is required in the ordinance, the City of Pullman was agreeable to develop an Interagency Agreement that allows WSU to review site plans, approve projects, and perform the inspections that Pullman would normally do.

 - a. Sustainability class will help with most of the work. However, it will be appreciated if faculty and other student groups are involved. Anyone who can help or contribute should, please, contact John Reed or Jamie Bentley. Outside vendors will be invited to participate. The organizers will send out notices. If you are interested in being involved in the organization of the fair, contact Ade Snider and she will invite you to the organization/planning meetings.
