2. February is Heart Health Month – time to check your AEDs.



- 22 of the incidents were OSHA recordable
- 45 incidents were employees
- 16 incidents were student employees
- 4 incidents were students only
- 4 vehicle accidents
- 11 incidents were volunteers
- 20 incidents were falls
- 8 incidents were exposure to harmful substances or environments
- 27 incidents were contact with objects or equipment
- 16 incidents were from bodily reaction or exertion



Discussion points:

Though incident reports were higher this year than last year, it is not necessarily an indicator of unsafe behaviors. Employees are encouraged to report incidents so situations can be discussed and ideas generated on how to avoid similar incidents in the future. Some locations are reporting "near misses." This allows us to discuss issues that can help avert actual incidents. Percipio training also helps to keep folks constantly thinking about safety.
