Native Center for Alcohol Research and Education 2019 Call for Pilot Grant Applications

PURPOSE

The primary intent of the Native Center for Alcohol Research and Education (NCARE) Pilot Project Grant Program is to fund and foster innovative research projects that focus on reducing the burden of alcohol use disorders (AUDs) in American Indian and Alaska Native (Al/AN) communities. The secondary intent of the Pilot Project Grant Program is to support and provide mentorship to junior investigators during the development of their novel approaches to improving the lives of AI/AN people.

ELIGIBILITY & TERMS OF SUPPORT

Funding will be provided for one or more proposals. Proposals may request up to \$40,000 in funding, and the project must be completed in one or two years. Indirect costs will not be provided. Pilot grant recipients are eligible to receive ethical, statistical, and data management support from NCARE investigators and cores.

To be eligible, applicants must:

- Plan to conduct research with AI/AN individuals or communities on a topic related to AUDs and their related health conditions:
- Have an advanced degree in social, behavioral, or health sciences or a similar field:
- Be a postdoctoral fellow or junior faculty member who has no experience with National Institutes of Health (NIH) R01 funding OR an associate professor who has received previous R01-level funding but has not worked with AI/AN communities in the past;
- Be up to date with human subject trainings (Collaborative Institutional Training Initiative - CITI) or commit to completing said trainings before final review by the NCARE Pilot Project Core Review Committee (NPPCRC).

APPLICATIONS

This call for grant applications is an effort to promote innovative research projects that will reduce the burden of AUDs in AI/AN communities and that will subsequently lead to future external funding. Please refer to the website for full application details. *Initial* application materials must be submitted for first review by September 30, 2019, at 4:30PM PST.

REVIEW PROCESS

The review process consists of two levels. First, NCARE Pilot Project leads will review the submitted Letters of Intent (LOIs) for scientific merit and programmatic priorities. Applicants should expect to be contacted to answer any questions or provide clarification. The Pilot Project leads will then invite applicants with meritorious LOIs to complete a full application.

After initial review for scientific merit, the NPPCRC will conduct a second level of review to assure that meritorious applications are consistent with NCARE objectives. With rare exceptions, no funding will be provided until all relevant IRB and tribal approvals have been obtained. Individuals who are not funded may resubmit an application during the next call for applications, which is anticipated to occur annually. The NPPCRC will make funding recommendations to the NCARE Steering Committee in consultation with the NIAAA.
