Dear Fair and Fat Stock Sale Participants,

Fairs and Fat Stock Sales are quickly approaching. The Livestock Identification Program is here to support your efforts. Due to COVID-19, and the Safe Start Washington – A Phased Approach to Recovery, many local and county fair livestock organizers, are thinking “outside the box” as to how to support the youth selling their steers. Please keep in mind that no matter what the platform your sale committee chooses, the steers require a brand inspection, both to the youth and to the buyer or processor per RCW 16.57.160, WAC 16-610-018, and WAC 16-610-020.

Here are a few scenarios that we have heard about:

- Market steer sold directly to a buyer from youth’s backyard. (No special sale permit required)
  - The youth must have proof of ownership and/or a brand clearance to sell the steer.
  - The steer must be brand inspected to the buyer as well.
  - Buyer needs clearance to take animal to processor.
- Virtual sale of steer using video or picture. (No special sale permit required)
  - The youth must have proof of ownership and/or a brand clearance to sell the steer.
  - The steer must be brand inspected to the buyer or processor as well.
- Market steers sold at live auction. (Sponsoring organization must get a special sale permit)
  - The youth must have proof of ownership and/or a brand clearance to sell the steer.
  - The steer must be brand inspected to the buyer or processor as well.

Brand inspectors are able to come to weigh in sites to brand inspect as well as clear all steers for market sale and processing.

Please coordinate with your local brand inspector to troubleshoot and work out details for your specific market needs or contact them with any questions.

## 4H/FFA SPECIAL SALES

Everyone has to complete for branded or non-branded steers:

- Certificate of Permit – Haul Slip (see sample)
  - Includes lot number from weigh in

For kids who have brand inspections, showing change of ownership into their name:

- Brand Inspection Certificate

For kids who do not have a brand inspection, they must have:

- A signed and dated bill of sale (see sample)
- A completed Affidavit of Sale form (see sample)

For kids that are listed on the registered brand for their animal or their home-raised animal has no brand, they only need a Certificate of Permit – Haul Slip
