# 4-H State Advisory Board October 24, 2020 Zoom Meeting

The State 4-H Advisory Board meeting was called to order at 1:30 pm by President Jean Lindsey.

### Treasurer's Report

The checking account balance is \$9,451.51. This includes \$3,505.51 in the 4-H State Horse Program account. From June 26 to October 19, 2020, the investment account increased almost by almost \$2,000. As of October 19, there was \$21,474.80 in the investment account.
