Discussion of draft changes to LMAAC policy.

The updating of the policy and rules is a continuous process. Several comments were email for consideration from Lisl Thompson, who was unable to attend the meeting. Some of these were addressed as part of the discussion including:

Page 10: Duties of the officers etc. Bill is going to draft these duties to be more clear.

Page 12: Funding Educational Events – the committee has, and will continue to have funding available for events to support livestock members that are outside the scope of the Leader's Council EAS Scholarship program. These event include things such as, but not limited to: Shearing School, Judging School, Livestock Clinics, WCYF expenses not covered by EAS etc.

Page 14: Mandatory Weigh In. This is something that state WSU staff recommended as part of their 2015 review. The spirit of the discussion is that it is important for many reasons. Besides identification and weight recording of animals there are many other benefits to a mandatory weigh in.

Page 15: regarding outdated information on the requirement of Representative Hen. This is no longer a requirement and needs to be deleted.

There was also some discussion of weigh in order, biosecurity concerns, and the importance of giving market animals priority to the scales over 4-H non market and open class animals. Also a reminder that ALL Market Animals are to be brought to the scale clipped (per department), clean, and dry.
