Treasurer's Report – Randi Mayberry: Preliminary numbers from the Auction were provided. Final annual report will be completed no later than Dec. 31, 2015 and turned in to the WSU office and Leader's Council.

Auction income was very strong grossing \$70,427.36 of that there was ~\$7,510.00 of processing fees for the IGFC butchering; \$51,800.98 paid to members and \$9,508.25 in turn back revenue.

The use of Credit Cards was very successful! 26501.00was processed through the credit card "square" and the fee for this was 2.75% which was \$742.05

Overall the auction was the most successful auction in recent years!

Old Business:

New LMAAC Paperwork: There was discussion about the amount of time the auction paperwork requires to complete for the sifting committee at fair. Leaders were thanked for making sure the paperwork got completed accurately.

IGFC Slaughter, Cut and Wrap: Eric reported that the slaughter process went very well with IGFC. Bill commented that the quality of their work was very good cutting and wrapping. LeAnne thought the cost might be higher with IGFC than in the past. Bill complimented the Guards for accommodating the processing of the market animals on their farm. Hopefully 2016 will be smoother with the curing of pork done off island. Bill expects that the cutting, wrapping, and butchering fees may be less expensive next year; he is working on that with IGFC.

Coats: Since the Skagit Farmers is no longer sponsoring the Championship Jackets. There had been some discussion about LMAAC sponsoring jackets but that never happened. Jan will look into jacket costs, and options, and report back.

Sifting Committee and Fair Weigh In: Overall the process was successful. There was discussion about ways to streamline the paperwork. Great work by everyone involved!

Other: Bill announced that Lorin and Mikayla Geiser have agreed to be Beef Superintendents at the 2016 fair.

There was some general discussion about drafting a proposal for EAS funds to be provided from the turn back sales and that Leader's Council would then manage the funds and the scholarship application/approval process. The majority of LMAAC leaders support this. A proposal will be brought to the next LMAAC meeting.
