Mostly relatively small-scale buyers in urban Thurston County




Figure 1. Grain Usage Among Local, Small-scale Buyers in Thurston County




Figure 3. Importance of Using Local Grain Among Buyers




Figure 4. Motivations Among Buyers for Using Local Grain




Figure 5. Willingness Among Buyers to Pay a Price Premium for Local Grain
