Wednesday, October 4th

Taste Washington Day is a day for school districts around the state to celebrate Farm to School and local agriculture. This year, on Wednesday, October 4thnutrition services staff, school gardeners, teachers, administrators, and volunteers all over Washington will serve school meals with local ingredients and do activities to help children learn about the farms that feed us.

Cafeterias across the state celebrate how Farm to School looks in their district by featuring local and Washington-grown products, farmers sign up to supply ingredients or speak at a local school, school gardeners host classes or lunchtime in the garden, and teachers do food and agriculture related lessons in the classroom.

Resilerator Northwest: Business Skills Intensive For Mid-Scale Farms

Looking to grow your farm business into a thriving and resilient enterprise?

Seeking a strong foundation to scale up your production and systems? The Resilerator is like a business accelerator, but with an emphasis on long term sustainability instead of the rapid pursuit of short term profits.

Join Northwest Agriculture Business Center for an 11 week business skills intensive. Limited to a small number of growers, this cohort-based program will meet weekly from October to December 2023 for discussions with experts and farmer peer-to-peer support.

Our program will begin with each participant completing a thorough Business Resilience Self-assessment. During the program, participants will use the self-assessment to identify goals and actions to be taken, and at the end of the program each participant will receive an hour of one-on-one technical assistance related to their goals.

Each week participants will watch a video on their own time, then come to class prepared with questions for an in-depth discussion. Each class will have a local farmer or service provider to provide a short presentation and enhance the discussion.

Course requires a \$200 deposit which is fully refundable upon graduation from the course.

Registration:

Priority application deadline August 1st, 2023. Applications will be accepted until the cohort reaches 20 farmers. Registration closes September 15th.

Who is eligible to participate?
This agricultural intensive has been designed for (but not limited to) mid-scale farmers who:

- Operate in Island, King, San Juan, Skagit, Snohomish, Whatcom, Lewis, Thurston, Grays Harbor, Pacific, Mason, or Pierce counties.
- Can commit to ~40 hours of time over three months.
- Have a current gross farm income of ~\$100,000 or higher annually.
- Have been in operation for three or more years.
- Have been selling wholesale at least one year or accessing market channels beyond farmers market and CSA.

Ethnoveterinary Data in Britain & Ireland: Can Native Herbal Medicine Promote Animal Health?

Antibiotic and multi-antibiotic resistant is a problem in managing intestinal parasites in grazing animals. It is critical to use dewormers appropriately, and explore a variety of strategies to manage these pests. The study here is interesting work being done in England and Ireland exploring native herbal remedies for managing intestinal worm populations. This traditional ecological knowledge is at risk of being lost, and is potentially very helpful in pest management. Increasing Land Access, Security, and Opportunities Act

There is an opportunity to communicate with Senators and Representatives about the Increasing Land Access, Security, and Opportunities Act (H.R. 3955, S.2340).

If enacted, this legislation would expand the USDAIncreasing Land, Capital, and Market Access Program and authorize \$100 million in annual funding for community-led solutions to the land access problem facing young and BIPOC farmers through the 2023 Farm Bill. This would provide resources to young farmers, ranchers, and others seeking equitable land access, retention, and transition options.
