#### LIVESTOCK WEIGH-IN

The scales will be open for entrants to weigh their animals until Wednesday night, April 20. Then it will be locked until official weigh-in on **Thursday**, the 21st from 12 to 6:00 pm. The beef arena will be closed so you will **line up in the large parking lot across from the main gate**, then proceed to the scales and out the back gate.

### **SMALL ANIMALS**

Small animal exhibitors, please use back gate to bring in entries from 12 to 6:00 pm on April 21st.

# OUT-OF-STATE HEALTH REQUIREMENTS FOR CATTLE

### **AND SWINE**

All out-of-state cattle and swine are required to have a Certificate of Veterinary Inspection (health certificate) listing official individual identification and an entry permit number, which may be a blanket permit number issued to individual fairs.

This requirement pertains to Asotin County 4-H and FFA members who are housing either market or breeding cattle or swine in Nez Perce County, Idaho; or in other counties bordering the State of Washington.

All out-of-state animals going to fairs (sheep, goats, etc.) must have a Certificate of Veterinary Inspection.

# NOTE FROM WSDA BRAND INSPECTOR REGARDING ASOTIN COUNTY

### **FAIR BEEF ANIMALS**

All 4-H and FFA members exhibiting steers need to present a signed haul slip when they unload their animal at the fair. WSDA regulations require exhibitors to have a brand inspection— Branded or not. The only exception is if the youth raised the steer themselves; or is branded with their own brand. The cost for brand inspection is less than \$10 Please do not make the brand inspector write all the inspections at the fair! It is recommended that the fair exhibitor gets ahold of the breeder ahead of time so the paper work is done beforehand. The haul slip, brand inspection and health record/quality assurance form all need to be presented before the steer crosses the scale to be weighed. Questions? ### LIVESTOCK HEALTH RECORDS (QA)

A WSU Health Record Form (Quality Assurance Form) must be submitted (signed and properly completed) by all 4-H & FFA market beef, goat, sheep and swine exhibitors when weighing in their animals. **NO EXCEPTIONS**. Individuals that do not have a completed Health Record form on Thursday, April 21, will not be able to sell their animal through the livestock auction. Questions? ### LIVESTOCK MANURE RULE

To all 4-H/FFA youth taking a livestock project. All manure that is left by a livestock project must be shoveled and disposed of in the covered manure pits located outside of the livestock & horse barns.

This is to control the levels of manure and waste that ends up into the water system of the City of Asotin.

### SUPPLY YOUR OWN TOOLS AND TACK



### FAIR WRISTBAND INFORMATION

Wristbands will be available for **Livestock Exhibitors** after they attend **one** of the mandatory meetings on Wednesday, **April 20 at 7pm** or Thursday, **April 21st at 7pm**. Leaders may pick up wrist bands for all **other 4-H and FFA exhibitors** by visiting the 4-H office in Boyd Hall starting on Wednesday morning at 9:00 am. If you lose your wristband or it breaks, you need to visit the 4-H office in Boyd Hall to receive a new one.

### DOG & CAT RABIES VACCINATION RECORDS

Dogs and Cats must have current vaccinations before they are shown at fair. The vaccination form is available at the Extension Office or <a href="www.extension.wsu.edu/asotin">www.extension.wsu.edu/asotin</a>. Navigate to 4-H and Fair information page. The form must be signed by the veterinarian as well. Turn the completed form into the area superintendent at check in.

\*Only 4-H Project dogs are allowed on Fairgrounds

### **EXHIBITOR HANDBOOK INFO**

Be sure to refer to your 2022 Fair Book for all entry information. It is crucial that you know when to enter your fair items and that you meet the entry requirements, ie: photo labels, educational poster information, food portion sizes, etc.

The fairbook is available from the Extension Office and many local businesses throughout the valley.

### **Parking on Thursday of Fair**

There is a lot of traffic on weigh-in day. Please be courteous and mindful of where others will need to park. If you do not need to unload an animal, please do not drive up and park in front of the barns. All tack should be unloaded on Wednesday night.
