STILL LIFE EXHIBITS TO STATE 4-H FAIR

Thank you for sharing your 4-H Projects with the community during the Grays Harbor County Fair last week! The remaining 4-H Still Life entries (photos, educational posters, creative arts, etc.) have now been relocated to the WSU Extension office. If your still life exhibit received a blue ribbon placing, it has qualified to be exhibited at the State 4-H Fair in Puyallup. In order for those exhibits to be transported to the State 4-H Fair in Puyallup, you will need to complete your State 4-H Fair entry tags and forms during regular business hours at either the Grays Harbor or Mason County Extension Office no later than Tuesday, August 20 at 3:00pm.

You can also choose to transport your exhibit to State 4-H Fair yourself. Entry dates/times are as follows:

- Monday, August 26 1:00pm 6:00pm in the 4-H exhibit building. (Drive in at the service gate on the SW corner of the fairgrounds)
- Tuesday, August 27 9:00am 6:00pm in the 4-H exhibit building. (Drive in at the service gate on the SW corner of the fairgrounds)

These options/dates do not include foods and garden exhibits:

- For food items: Entries will be accepted on our County Day, Thursday, September 12 from 10:00am
 12:00pm, or on any day you will be at the fair participating in other fair activities from 10:00am
 12:00pm.
- For garden items: Entries will be accepted on August 30, September 12, or 14 from 10:00am 12:00pm, or on any day you will be at the fair participating in other fair activities from 10:00 12:00pm.

Reporting of volunteer hours documents coverage for injuries they might sustain and it is also documentation for the liability coverage WSU provides to its volunteers. All WSU Extension Volunteers must log on to https://volunteers.cahnrs.wsu.edu/logon.aspx each month to report hours they worked for any WSU Extension program. Your user name will be your last name and first initial, such as "HansonT" and your initial password is password! (all lower case and include the exclamation point!) Once you log in you will have the option to change your password.
