**TIME TO RE-ENROLL**

October marks the beginning of the new 4-H year. All youth members and adult volunteers must log into 4HOnline and update their profiles in order to re-enroll for the new 4-H year. Step-by-step instructions and a link to the 4HOnline enrollment site can be found on our website at <https://extension.wsu.edu/graysharbor/4-h/forms/> There are two options for payment of the \$25 Washington State 4-H enrollment fee. You may pay with a card online during the enrollment process, or select check and deliver a check payable to WSU to the Extension Office. Enrollments will remain pending until payment is received. **CLUB LEADER PACKETS DUE DECEMBER 2**

Club leaders - don't forget to return the forms from your Club Leader Packets to the Extension Office no later than December 2. We need:

- Club Chartering Documentation
- Annual Financial Summary – if you don't have a club bank account indicate that on the form and return. All clubs must submit this document.
- Audit Report
- Property Inventory List

Remember, starting in December the 4-H office will conduct an audit of 10% of our clubs. All documents were distributed at the Club Kickoff meetings. If you have any questions please let Tracie know, we are here to help and appreciate all that you do.

## FINANCIAL PROCEDURES REMINDERS

It is important that you develop a financial plan and system with your club, it is a great way for youth to learn how to set goals and priorities and develop financial management skills. Washington State 4-H Youth Development has created a one stop 4-H club financial resource page, <https://extension.wsu.edu/4h/for-clubs/club-financial-information/>.

- Club leaders, volunteers and members who serve in leadership or treasurer capacities are required to complete the 4-H Club Financial Management Training Video and attestation form found at <https://extension.wsu.edu/4h/for-clubs/club-financial-information/> prior to December 2, 2019. Please return the form to Tracie.
- If you raise funds you must have a bank account – no exceptions!
- Set financial goals – what club projects will need funds for this year?
- Develop a budget
- Identify your club's current financial status
- Create income
- Use a ledger to record every expense and deposit
- Checks must have 2 signatures – not members of the same family
- No mobile banking is allowed at this time

## STATE VETERINARIAN DISEASE ALERT: Equine Influenza Virus, Epizootic Hemorrhagic Disease and Rabbit Hemorrhagic Disease vaccine guidance

Put Equine Influenza, Epizootic Hemorrhagic Disease and Rabbit Hemorrhagic Disease on your radar this week.

### Equine Influenza confirmed in Spokane County

A seven-year-old Thoroughbred gelding and a five-year-old Warmblood mare tested positive for equine influenza (H3N8) at a premises in Spokane County, Washington, on November 15. Several other horses that attended a local show were also showing clinical signs including coughing, fever and nasal discharge. Neither of the horses were up to date on vaccines. The reporting veterinarian is overseeing a voluntary quarantine of the farm. **MESSAGE FOR 4-HERS: VACCINATE YOUR HORSES FOR EQUINE**

INFLUENZA EVERY 2 MONTHS IF YOU GO TO HORSE SHOWS THROUGHOUT THE YEAR. PROTECTION FROM THE VACCINATION DOESN'T LAST VERY LONG FOR THIS DISEASE.

### **Epizootic Hemorrhagic Disease confirmed in Grant County**

A two-year-old crossbred heifer tested positive for Epizootic Hemorrhagic Disease on Nov 19. The heifer presented with weight loss and bloody nasal discharge. This is the fourth premises diagnosed in Washington this fall. Previous cases were confirmed in Walla Walla, Franklin and Whatcom Counties. MESSAGE FOR 4-HERS: WATCH YOUR CATTLE CLOSELY FOR ANY SIGNS OF ILLNESS INCLUDING FEVER, DROOLING, MOUTH SORES, POOR APPETITE, BLOODY NOSE, ETC. CALL YOUR VETERINARIAN IMMEDIATELY IF YOU SEE THESE SIGNS. APPLY APPROVED FLY SPRAYS IF FLIES ARE STILL ACTIVE IN YOUR AREA—THIS VIRUS IS SPREAD BY BITING FLIES.

### **Rabbit Hemorrhagic Disease Vaccine Guidance Posted**

Rabbit hemorrhage disease (RHD), a highly contagious and serious disease of rabbits, was identified in the San Juan Islands in July 2019 and on Whidbey Island in November. To reduce risk of RHD on their premises, concerned rabbit owners should step up their [biosecurity practices](#). Rabbit owners in the [quarantine zone and control area](#) should discuss with their veterinarian whether or not to include vaccination as part of their risk reduction plan. Important points to remember:

- **Rabbit owners should be aware and practice the biosecurity necessary to protect their animals.**
- **The vaccine should NOT be widely used.** The vaccine should be used for rabbits with immediate risk only that are in or near a quarantine area or where wild rabbits are infected.
  - o WSDA established high risk area maps where the vaccine should be used (see link below).
  - o Highest risk rabbits are those with direct contact with feral domestic populations.
- **The vaccine supply is limited.**
  - o The company does not have a large capacity for production, so use should be discretionary and prioritized to animals at most risk.
  - o The vaccine is experimental and should be used at the owner's own risk.
- **Diseases in wildlife are difficult to stamp out.**
  - o RHDV is very contagious and quite likely will depopulate feral domestic rabbits in a given area.
  - o Other examples of wildlife diseases include Brucellosis infecting elk in the greater Yellowstone area, Chronic Wasting Disease in cervids, and Tuberculosis in deer.

MESSAGE FOR 4-HERS: FOLLOW THE BIOSECURITY PRACTICES MENTIONED IN THE ABOVE RESOURCES. ABIDE BY THE QUARANTINE/CONTROL AREA ORDERS AND DO NOT MOVE RABBITS OR THEIR EQUIPMENT INTO OR OUT OF THESE AREAS. DO NOT ADOPT FERAL DOMESTIC RABBITS FROM THE QUARANTINE AS PETS AND EXPOSE THEM TO CURRENT PET/PROJECT ANIMALS. CONTACT YOUR VETERINARIAN ABOUT GETTING YOUR RABBITS VACCINATED IF YOU LIVE WITHIN OR NEAR THE QUARANTINE ZONE. ALSO CONTACT YOUR VETERINARIAN RIGHT AWAY IF AN OTHERWISE HEALTHY RABBIT DIES UNEXPECTEDLY OR A RABBIT STOPS EATING, BECOMES LETHARGIC, OR YOU NOTICE BLOODY DISCHARGE FROM MOUTH OR NOSE. PLEASE ONLY SHARE FACTS ON SOCIAL MEDIA!

### **VOLUNTEER HOURS**

If you participated in the Grays Harbor Fair, a 4-H meeting, camp, or helped a member with their project you must report these hours. Reporting of volunteer hours documents coverage for injuries they might sustain and it is also documentation for the liability coverage WSU provides to its volunteers. All WSU Extension Volunteers must log on to <https://volunteers.cahnrs.wsu.edu/logon.aspx> each month to report hours they

worked for any WSU Extension program. Your user name will be your last name and first initial, such as "HansonT" and your initial password is password! (all lower case and include the exclamation point!) Once you log in you will have the option to change your password.
