## ***WSU Skagit County Extension Master Gardener Program***

### **Volunteer Application**

**DEADLINE: OCTOBER 31st**

Thank you for your interest in the WSU Master Gardener Program. The information on this application will help determine if you qualify for the program, so please give thoughtful consideration to your answers. Although the rewards of becoming a Master Gardener are many, the training is academically rigorous, and **requires a large time commitment for a 12-week training.**

As a first-year volunteer in our program, you will be expected to:

- Attend a twelve-week session of full-day classes, one day per week starting mid-January (attendance is required at all classes).
- Complete **online** Master Gardener training course work, including quizzes and a final exam. For best results, you should have access to high-speed internet and support Adobe Flash video.
- Pay a \$400 fee for the WSU Master Gardener program materials. \$75 will go directly to WSU for online training paid with a credit card. Two checks will be written, \$225 will be going to WSU Skagit Extension, and then another check should be written to the Skagit County Master Gardener Foundation (SCMGF) for \$100. The \$100 fee going to the SCMGF will be refunded if all volunteer requirements are met. Fees are due by **December 31<sup>st</sup>**.
- Volunteer in the WSU Master Gardener Program for a **total of 60 hours** to include
  - **16 hours** in the Burlington Diagnostic Plant Clinic
  - **4 hours** in Outreach Clinics (after completing 8 hours in Diagnostic Clinic)
  - **25 hours** in the WSU Discovery Garden

After the first year in the WSU Skagit County Extension Master Gardener Program your mandatory volunteer hours will drop to **25 hours per year along with 10 hours of continuing education.**

After the October 31<sup>st</sup> deadline, we will contact you to set up an interview.
