Ride Nights:

Ride nights at the County Fairgrounds begin the first week of May. Each weeknight is assigned to specific clubs by Horse Leaders.

Monday – VGA Tuesday – ARR Wednesday – BERR Thursday – TB Friday – HF/SVSR

Arena Guidelines

- > A leader **must** be present for the whole ride night
- > Only enrolled members and leaders are allowed to be horseback
- Members and leaders must wear helmets, boots, long pants, and t-shirts (no bare shoulders) when mounted
- Boots are required for any person handling horses
- > Riding in the arenas only; no riding in the parking area or on grass areas
- Parents must wear close-toed shoes
- > Dogs **must** remain in the parking area and on a leash at all times
- All children must be in eyesight of the club; please use good parental judgment!
- > NO smoking anywhere on the fairgrounds

All clubs work together to make the County Fair exhibit happen. Fair set-up and job assignments are handed out at the July Horse Leaders Meeting. Fair take-down assignments are made during the fair; leaders will be called to a meeting to discuss assignments as the schedule allows.

Fair MEMBER Participation Requirements

- Submit an up-to-date Record Book to Horse Leaders on or before the following date*:
 - May 19th @ Skagit County Fairgrounds, 5:30pm-6:45pm
- Participate in the county Public Presentation contest.
 - March 14th @ Where the Heart Is in Burlington, 9am-11:30am
 - March 17th @ Skagit Farmers Supply in Mount Vernon, 3pm-6:30pm
 - March 28th @ Where the Heart Is in Burlington, 9am-11:30am and 1pm-3pm
 - Online Registration, check with your leader for details
- Participate in a county Horse Bowl contest (all age divisions) or Hippology contest (intermediates and seniors only).
 - Horse Bowl: February 12th @ Burlington Lutheran Church Sharrie will make arrangements on an individual basis for those still needing this requirement.
 - Hippology: February 23rd @ Silver Quarters, 12:45pm
- Participate in a county Horse Judging contest.
 - April 19th @ Silver Quarters, 12:45pm (BERR, TB, and SVSR to volunteer)
 - May 2nd @ Silver Quarters, 8:45am (ARR, HF, and VGA to volunteer)
- Attend one Educational Event**
 - Equine Extravaganza January 11th @ Skagit County Fairgrounds, 8:30am-3pm
 - Country Living Expo January 25th @ Stanwood High School, 8:30am-4:30pm
 - Super Saturday TBA
- Submit signed Guardian/Member Project Expectations Agreement (page 6 of this packet) to County 4-H office on or before May 1st (with your Blue Slip) before 4:15pm.
- FINAL MAKE-UPS May 27th, 6pm at the Skagit County Fairgrounds: final chance to make up the Horse Bowl, Public Presentation, and Record Book requirements in order to show at the County Fair as a Complete Member.

* Members must make the May 19th submission deadline for Record Books. If book is found to be incomplete then the member has until the Final Make-Up date to complete the book. Books not turned in by the first deadline do not qualify for the extension and member will be considered "Incomplete".

** Other equine-related events may qualify for this requirement IF member has gained PRIOR approval for the event from the Horse Leaders Executive Board (may go through your leader). Proof of attendance and a ½ page summary of topics covered at the event must be submitted either in-person or to schorseleaders@gmail.com on or before May 1st.

Fair HORSE Participation Requirements (Main and Back-up Horses)

- Complete an up-to-date Project Record in Record Book (1 per horse).
- Blue Slip with color photo submitted to County 4-H Office on or before May 1st before 4:15pm (1 per horse).
- Flu/Rhino vaccinations between June 12th and July 28th must have signed documentation from your veterinarian. Horses without this record will not be admitted onto the Fairgrounds.

What is an "Incomplete" Member?

An Incomplete Member will show at the County Fair as a Substitute Horse, and will be required to help at a County event that is approved by the Horse Leaders committee.

- Did not submit an up-to-date Record Book, or did not submit a complete Record Book by the Final Make-Up date; OR
- Did not participate in one Public Presentation, Horse Bowl/Hippology, and Horse Judging contest, AND did not attend the Final Make-Up date; OR
- Did not attend an Educational Event; OR
- Did not submit a signed Guardian/Member Project Expectations Agreement

What is a "Substitute" Horse?

A Substitute Horse cannot win Grand or Reserve in any class at the County Fair, and does not qualify for any State Team. This includes horses substituted due to illness or injury after the May 1st deadline.

- Incomplete Member
- Does not have an up-to-date Project Record in member's Record Book.
- A Blue Slip was not submitted by May 1st. All horses must have a Blue Slip submitted to correspond with their vaccination record.

State Fair Double Qualifying Opportunity

Members will have an opportunity to double-qualify for State Fair at the July Clover Classic. To qualify:

- Horse must qualify for the County Fair, see Fair HORSE Participation Requirements above.
- You must enter all qualifying events for that discipline at either the Clover Classic or Skagit County Fair.
- You must compete in a different discipline at the Clover Classic than you will compete in at the Skagit County Fair.
- You must attend and compete at the Skagit County Fair.
- The following State Fair classes may or may not be offered at the county level. Members may still qualify for State in those classes. If interested, contact the Fair Superintendent:
 - o Dressage
 - Reining (seniors only)
 - Small horse classes (more info to come)

Our County and State events are planned, managed, and staffed entirely by volunteers. Volunteers are usually Horse project leaders, alumni, members of the horse community, parents, friends, and relatives of horse project members.

It is expected that a parent, guardian, or other responsible adult associated with each member that is participating will provide support at horse project events. The intent of this is to set an expectation of volunteer service for the Horse project, as well as to facilitate smoothly-run events. Parent/adult representative participation is expected and is vital to a 4-H member's success. Each member needs an advocate and a support system!

Leaders should make parents aware of this expectation.

Leaders need to have a relationship with members ad families. It is difficult to make a project, with as broad a scope as the Horse project, be successful if there is not a Leader/Member/Parent (adult) connection.
