Positions available:

Teen Counselor (TC): Must be at least 16, but not older than 19 years old by the first day of camp. Provide leadership to small groups and assist with general camp activities, for example: song leading, crafts, skits, etc, not including special activities listed below.

Teen Program Assistant (Teen-PA): A Teen (16-19 years old) who is a specialist in a particular activity, for example: waterfront, canoes, archery. Depending on experience this teen may fill a TC or CIT role.

Counselor in Training (CIT): A teen 14 years of age or older who assists a Teen Counselor in similar duties as assigned.
