The Regional Specialist interviews will be held March 16th and 17th. More details will be sent out on location and times when the extension has them.

Question from Mike Vogel: Has the previous agreement that allowed archery to use the fairgrounds been signed by all parties yet?

Abby will check to see if the agreement has been signed yet and verify that it is posted on the web site.

Question from Mike Vogel: Do we know what the fees or percentage of fees that archery is going to have to pay for use of the fairgrounds? In the agreement WSU was going to pay the fairgrounds and Archery was going to pay them back. Have they figured any of that out yet?

Abby: has not heard anything on that subject yet but she would pass it on the office.

The survey is just a draft and Abby would like comments then the survey will go out to all county 4-H is scheduled to go out on Monday.

The Washington DC trip is pretty well set. We have 10 teens confirmed going. The down payment will be sent in by 11 March. There was a meeting with the teens and parents on February 27 and 29 evening to go over fund raising ideas. Funds needed will be about \$13,000.

Leadership training class for new leaders will be presented on the 12 March at Olympic View Community Center from 12 to 4.

Council and Officer Board Reports

Talked to Becky about Camp. Still waiting for the agreement to be returned from WSU.

Talked about Teen travels and running the money through the council treasurer rather than the State Foundation to save the 8 % usage fee they require.

Under new business a proposal to not require campers who join 4-H just for camp to pay the \$5.00 council fee. The extension office does not charge them the \$20.00 fee.

Twin Lakes update: There is a draft Quick Claim Deed between ORM and 4-H being worked out to transfer the property to TLYC through ORM.

Camp inventory No status, looking for a place and time to perform this function.

Camp Program : In a holding pattern waiting for the rental agreement to be returned from WSU. Teens working on Planning and preparing the program. Have the Teen staff we need still looking for a second lifeguard and more adult staff. Camp meetings are posted on the web page.

Teen Leadership: Trip to KYG there was no teens to give report. Marcia gave her report from the adult prospective. It was a crazy time where the Teens had many workshops to attend. They were also able to run for office 4-H Governor.
