- b) Joy Lile shared that TSC is doing a paper clover drive to raise funds for 4-H. Sheila clarified that TSC holds two such fundraisers each year, one in the spring and one the fall. There was discussion about where the funds would go and what they would be used for. Port Orchard TSC reached out to Joy Lile asking for 4-Hers to come and support during the paper clover drive. Silverdale TSC is also an option.
- c) Joy Lile brought folders to share, fliers on parent involvement to support, a letter from Nancy Darlinger, the state program director for 4-H, and a self-quiz for assessing your youth-adult partnership in your club
- d)Lis Nilsson shared the mall showcase reminder- Oct 13<sup>th</sup> is the Welcome to 4-H event at the Kitsap County Mall. May need additional pop ups for outside mall for livestock. There will be a roped off area for horse trailers outside Sears. The event starts at 12:00 and is over by the kid's play area outside of Sears area. Lis meets with mall supervisors on Friday of event. There will be a 4-H showcase each 2<sup>nd</sup> Saturday of each month for the year. Four clubs have signed up for future dates. There is a 2<sup>nd</sup> 4-H mall partnership,

the Live360 partnership. This is organized and supervised by two different people, it is important that Lis Nilsson be the 4-H Point of Contact for anyone wishing to coordinate with the mall for communication and clarity sake. Archery and 4-H store studio is being rented, the contract is with WSU. Julie Mirth and the 2x4s 4-H club will be meeting in the Live360 store spaces. There is a place to hang photography at the mall. For the October 13<sup>th</sup> event, folks can send materials if not able to attend in person. Lis will be accepting enrollments at the mall. Local media will be covering event. Lis is out of the office, contact Joy Lile and Sheila if you need assistance between now and day of mall event. Anyone can do public archery demo shoots at the mall with the insurance being used with proper range master and sign in.
