

Camper Behavior Contract 2023

Kitsap 4-H Camp Management

Rules are made not to restrict people from having fun but to assure that everyone can have fun and be safe, too. The warnings are being stated to make you aware of the risks involved in being out of doors and at camp. The following rules are to be read to your child before attending Kitsap 4-H Camp and then signed by both guardian and camper.

1. Campers are expected to remain on the Panhandle Lake 4-H Camp grounds once checked-in.
2. Campers are to follow all Kitsap 4-H Youth Camp rules and 4-H rules.
3. Campers must stay with their group during all camp activities. Restroom breaks will be taken as a group or with a buddy.
4. Campers are not allowed to have matches or lighters. Fire is a very real hazard at camp.
5. Campers are not allowed to have knives, fire arms, or weapons of any kind.
6. Campers will be sent home if found with cigarettes, alcohol, chewing tobacco, illegal substances including marijuana, or fireworks.
7. Campers will not deface any property.
8. Campers will not use profanity.
9. Fighting will not be allowed.
10. If a camper brings valuables it will be at their own risk, as the camp is not responsible for lost or stolen items. Please leave them at home. There is no need for money.
11. There is a phone available for parents to contact their children in case of emergency. The camp director will supply parents with the phone number at registration. No cell-phones are permitted during camp sessions for campers or counselors. If a phone is brought to camp, the phone will be held by the Camp Director until end of the day. Cameras for picture-taking are welcome.
12. It is the responsibility of every camper's parent/guardian to provide for the campers' own accident and health coverage beyond the limits of the camp coverage.
13. Parents may visit camp after making a reservation with the Camp Registrar. The Registrar will verify that the time desired is appropriate with the camp program. No one may show up without a reservation.
14. If a camper's behavior is deemed unacceptable, the parents/guardians will be called and asked to pick up their child. No refund will be given.
