

# NOXIOUS WEEDS CONTROL

2022

## BY THE NUMBERS

- 75 acres controlled for noxious weeds
- 20 Miles of PUD corridor managed for Scotch Broom
- 20-miles of County Roads controlled for wild chervil
- 17-acres of Poison
   Hemlock were
   controlled within the City
   of Port Townsend
- 2000+ Hours of WCC "boots on the ground work"
- 300 Citizen Interactions
- 5 Contractual collaborations with public agencies to facilitate noxious weed control.



#### **ISSUE**

Noxious weeds can reduce crop yields, destroy native plant and animal habitat, damage recreational opportunities, clog waterways, lower land values, create erosion problems and fire hazards, and poison humans and livestock. In Washington State, noxious weed is a legally defined term in the RCW 17.10. The Jefferson County Weed Control Board has a stated mission "To serve as responsible stewards of Jefferson County by protecting the land and resources from the degrading impact of noxious weeds."

## **RESPONSE**

The Jefferson County Noxious Weed Control Board has focused their efforts on controlling a variety of noxious weeds through work with the Washington Conservation Corps, spreading awareness through outreach campaigns, and by providing technical support to the public. This year's targeted species were poison hemlock, wild chervil, teasel, Scotch broom, and tansy ragwort.

The weed board has worked to control these species through contracting 2,000+ hours of Washington Conservation Corps crews.

## **IMPACTS**

- The Jefferson County Weed Board provided technical support to 300+ individuals during the 2022 calendar year. The program advised on the control of specific noxious weeds and recommended revegetation strategies.
- The program also surveyed city and county roads and rights-ofway for noxious weed, tabled at the Farmers Market, and hosted scotch broom pulls for East Jefferson Little League.
- The program has achieved an increased awareness surrounding noxious weeds within the public entities of Jefferson County shown by our partnerships. Our main partners are the Public Utility District, the County Public Works Department, the City of Port Townsend, Fort Worden State Park, and the Jefferson County Solid Waste Facility.
