## 78th St. Community Garden - 2018 Season General Rules

**Hours:** Dawn to dusk.

**Vehicles:** Vehicles are prohibited from being driven and parked by the gardens except to deliver materials, after which they should be parked in the parking lots on the south and west side of the Heritage Farm administrative building.

**Garden Access:** Gardeners will be given the farm **pedestrian gate code** for access to the garden and are notified of changes to the code. Please close the gate when you leave.

**Handicap access.** Gardeners with current handicap stickers or license plates will be allowed to park near the gardens as long as they do not block vehicle or tractor routes. Please ask at the front desk to open the front gate (knock if the front door is locked) during business hours 8-5 M-F.

**Delivering materials.** Gardeners delivering materials may ask at the front desk to open the front gate (knock if the front door is locked) during business hours 8-5 M-F. They will be issued a temporary gate card to drop materials off at the gardens. However, gardeners need return the gate card and park in the parking lot immediately after dropping off materials (approximately half an hour).

**Pets:** Pets are prohibited on the Farm, please leave them at home.

**Alcohol and Drugs.** Alcoholic beverages and illegal drugs are prohibited on the Farm; no smoking or e- cigarettes allowed.

**Home use of produce.** Produce is intended for home use, please do not sell or use garden produce for profit.

**Children:** Gardening is a fabulous family activity! However, please directly supervise and be responsible for your children while working in the garden. Do not allow them to roam unsupervised out of your garden plot.

**The garden is chemical-free.** *Much of the farm uses limited or no chemicals, except where absolutely necessary for maintenance or research.* Please do not use synthetic chemical fertilizers, pesticides or herbicides in your garden plot. If you have a question on what is considered safe or organic, please check with the community garden coordinator. This is one of the guiding principles for all land management at Heritage Farm. See [sustainable agriculture](#) for more information.

If you see a gardener using chemicals in their plot and do not feel comfortable speaking directly to them regarding this chemical use, please contact us and we will remind the gardener(s) that the garden is chemical free (we will keep your identity anonymous).

**Water Use Guidelines:** Please conserve water by adhering to the 78th St. Community Garden Water Guidelines found on the last page of this document.

**Tools:** Gardeners provide their own tools. If you leave tools onsite, it is advisable to have your name on your tools, watering cans, etc. If you use the few garden-owned tools in the shed, please clean and return them to their proper place when done. *78th St. Community Gardens are not responsible for damaged or stolen tools.*

**Soil Amendments & Compost:** Gardeners must provide their own soil amendments, including compost. At certain times, we may provide wood chips, leaves, or such, and we will announce this to the group. These will be available to all on a first come, first served basis.

**Allowable Plants:** Annual vegetables, flowers, herbs; small perennial herbs/plants (i.e. artichoke ok); **no trees**. Avoid shading your neighbors' plots with your trellis, etc.

**Harvest Your Own.** Unless invited, harvest only your own produce and flowers from your assigned plot. **Harvesting or removing anything from another garden plot without permission is considered stealing and will result in the permanent loss of your plot without a refund.**

**Donating Produce.** If your garden produces more than your needs, you are encouraged to contribute a portion of the harvest to an agency that will channel the surplus to those who need it. ### Garden Plot Care & Maintenance

- Please begin work on your garden plot within two weeks of the date assigned the plot (weather permitting).
- **Consistently attend to your plot and pathways**, weeding, harvesting, watering, and checking periodically as necessary.
  1. **Keep your garden free of overripe, rotting and spoiled fruit and vegetables;**
  2. **Keep paths adjacent to your parcel at their original widths and free of weeds;**
  3. **Keep your crops trimmed out of all pathways; plants extending into the pathway will be cut back.**
- **Renters neglecting their plots will be notified and given two weeks to clean up their plot.** Continued inactivity will be viewed as abandonment of the garden plot and the renter will forfeit the plot without refund. Consider arranging for someone to take care of your plot if you are ill or on vacation. *The community garden and its coordinator are not responsible for the upkeep of your plot.* Please notify the coordinator if you become unable to maintain your plot.
- **Winter Use & Preparation.** You are invited to garden over the winter, however please note that water will be shut off until the spring; please remove hoses and irrigation. If you do not choose to grow over the winter, clear all dead plants and harvest any remaining vegetables to prepare the ground for the winter season. Remove cages and properly mulch the ground for winter by November 2018. **Do not use hay and/or grass clippings as mulch since they can spread weed seeds!**

## 78th St. Community Garden - Watering Agreement and Guidelines

One of the guiding principles for the 78th St. Heritage Farm Site is to: *Showcase and promote sustainable and commercial agricultural practices*

As farmers and gardeners know, water is a limited resource. Water conservation is beneficial to the environment and your community garden neighbors. Conserving water means more water availability for everyone (plants, animals and people). In order to follow the site's guiding principles, we have created water conservation guidelines for the 78th St. Community Garden.

Participation in the gardens includes an agreement to follow the water conservation guidelines listed below. Failure to meet the guidelines will result in a warning and if repeated may result in termination of your plot without refund.

### Watering methods

#### Acceptable watering methods:

- 1) Hose with nozzles/watering cans
  - Dig a moat/trench in a circle around the plants.
  - Water each plant individually—close to the roots.
  - See below for more tips and ideas for watering with a hose.
- 2) Soaker hoses/drip irrigation
  - Drip is very effective and if done right, only needs to be turned on for less than 5 minutes at a time and waters your whole garden! You need to be present and monitor your system. **Please do not turn it on and leave the site.**

#### Unacceptable high water use methods:

- Overhead sprinklers.
- Flood irrigation in full rows.

### Water conservation tips and pointers

- Dig with a trowel to the root depth, squeeze a handful of soil; if it sticks together it does not need to be watered.
- Water in the early morning (preferable) or evening, not the hottest part of the day.
- Do not stand in the garden and spray the plants/ground lightly every day. This is not an effective watering system, is wasteful, and waters the weed seeds, too! Water thoroughly and less often to encourage roots to seek water and nutrients deep in the soil. With an extensive, deep root system, plants are better able to withstand dry periods. When watering, soak the soil to a depth of at least 6 to 8 inches.
- Know how much water each plant needs. For example, beans typically need a lot of water, whereas tomatoes need much less (and can be dry-farmed!)
- **Overwatering.** Check plants for moisture before watering. If the leaves turn yellow and drop, you could be overwatering. Over-watering can cause just as much damage to the plants as under-watering. Vegetables like moisture, but over-watering is harmful. Over-watering prevents the roots from getting air.

- **Under-watering.** If your plants look wilted on a hot summer afternoon, that's normal. They will usually perk up overnight. If plants are wilted in the morning, don't wait—water. Look for clues such as curling leaves, a grayish color and permanent wilting, which indicate under watering.
- Keep your plots weeded. Weeds steal moisture from desirable plants.
- Consider mulching; it creates a barrier that reduces evaporation.
- **Milk Jug Watering.** Try cutting the top from gallon-size milk jugs, punch very small holes in the bottoms, and set them in the ground with only the neck showing above the surface. Use one jug near (or between) each large (tomato or squash) plant and fill it with water once or twice a week (or more often if needed). When the plants start fruiting (fruits are the size of a quarter), add one or two teaspoons of a complete organic fertilizer, such as 5-10-10, to each jug once a week. You can use large cans in place of jugs.
