## WSVMA NEWS ALERT - RABIES FOUND IN PET CAT IN WASHINGTON

Good reminder to encourage 4-H'ers to keep their animals up-to-date on rabies vaccinations.

For the first time since 2002, a pet cat in Washington has been found to have rabies. The two year old female cat from Chimacum tested positive on Tuesday, according to Jefferson County Public Health. The cat has been euthanized.

The owner was bitten sometime in the past week. Several people, including the cat's owner and a veterinary technician are being given rabies shots as a precaution. The most likely scenario is that the cat contracted rabies from killing and/or eating a bat, as bats are the most common carriers of rabies in the state.

## YAKAMA LEGENDS CASINO GRANT APPLICATIONS

Yakama Legends Casino and its employees understand the importance of being good citizens to the Community and that this is paramount for good business.

Legends gives two percent (2%) of their Class III Table Games Revenue to a Community Impact Fund. Funds are then distributed once a year by a Community Impact Fund Committee. This committee is made up of five local community government representatives. These funds have made it possible to purchase fire trucks, ambulances and police vehicles. They have also provided funds for road improvements and other community projects.

Yakama Legends Casino also has other payments for impact costs, community impacts, and charitable donations from 1% of the CIII gaming revenue machines. One half of the 1% is for charitable donations and the other half of the 1% covers the impact costs and tribal community impacts.

Applications for the non-Tribal non-profit organization can be submitted yearly to the Charitable Fund Committee from January 1 through March 31, and these funds will be distributed in May of each year. Applications need to be made in a letter format stating:

- 1. Name of Organization
- 2. What this Organization does
- 3. How much money the Organization is seeking
- 4. How this money will be utilized (spent)
- 5. A copy of a Certified Washington State Non-profit Status Form (4-H Office has this form )

### **SUMMER OUTBOUND OPPORTUNITIES**

American 4-H aged youth are eligible to apply for cultural immersion experiences in Japan, Costa Rica, South Korea and Norway during the 2016 summer months through the 4-H International Exchange Program. All programs include pre-departure orientation, adult chaperone, homestay with a local family, and cultural learning opportunities.

All of the programs emphasize cultural immersion in a family setting (not tourism). Delegates may do some site seeing, but primarily will be experiencing life with a family which something tourists are not able to do.

Through participating in States' 4-H International programs, youth can develop essential life skills including critical thinking, resiliency, empathy, and self-responsibility. Please see below for brief outlines of each country experience.

## OTHER 4-H NEWS YOU CAN USE

### **BACKYARD CHICKEN KEEPERS**

Raising chickens in the backyard has been increasing in popularity. Chickens are now being raised in the backyard for egg/meat production or just a family pet. Protect your flock by practicing good biosecurity. Monitor your birds closely and contact your veterinarian and WSDA immediately if you suspect illness.

Here are some good biosecurity measures to follow:

 Keep your flock away from wild or migratory birds, especially waterfowl.

- Isolate any ill animals and contact your veterinarian and WSDA.
- Wash and disinfect items going on and off your farm, such as footwear, vehicles and equipment.
