#### Vaccination Mandate Lifted For All 4-H Volunteers

In coordination with Washington State University, CAHNRS Extension and the State of Washington, Washington State 4-H will no longer require 4-H volunteers to receive either a COVID-19 vaccination or an approved Religious or Medical Exemption as of October 31, 2022.

The memorandum from WSU Extension Associate Dean and Director Vicki McCracken to all Extension faculty, staff and volunteers can be viewed **HERE**.

#### What does this mean for WSU 4-H Extension volunteers (Leaders)?

- Volunteers who chose to take a leave of absence during the 2021-22 4-H Year may return to active status in 2023.
- New volunteers who apply to become WSU Extension 4-H Volunteers during the 2022-23 4-H year are not required to be vaccinated against COVID-19.

Washington 4-H sincerely thanks the volunteers who have helped navigate the program through uncharted territory over the past couple of years and look forward to an exciting new 4-H year, full of increased opportunities for youths and volunteers.

#### **Annual Financial Summaries**

Annual Financial Summary Report for **October 1, 2021 to September 30, 2022 are due December 1.** If your club does not have a checking or savings account, please make a note to that fact on the form, <u>sign the form</u> and return it. Any forms that are not completed or signed will be returned. Instructions are in the <u>Leader's Guide to the Treasurer's Book (C1059E)</u>. If you have any questions, please contact Bonnie at the Extension office 574-1600.

#### 4-H Club Bank Accounts and EINs

4-H Clubs are given non-profit status under the umbrella of the Washington State 4-H Program. 4-H clubs must be a chartered club in good standing, in order to have a bank account, to fundraise, or to accept funds or gifts and claim non-profit status for their club. To have a 4-H bank account, clubs are required to have an EIN with the IRS. New EIN applications **must** be <u>completed by 4-H office staff.</u> Please contact Bonnie, 574-1600, if your club needs an EIN. Clubs are **NO** longer allowed to have "shoebox accounts". Clubs are not required to have bank accounts or EINs, but learning about money is a truly valuable life skill.

#### 4-H Age Requirements

4-H is open to all youth who have reached their 5th birthday (on or before October 1st of the current 4-H year) through those who have not reached their 19th birthday (on or before October 1st of the current 4-H year). The following age groups (as reflected on October 1st of the current 4-H year) are identified for special programs and activity participation, including all competitive events/activities, within the WSU 4-H youth Development Program:

- Cloverbuds: 5 to 7 years of age (may participate in age-appropriate activities and projects. May not participate in competitive activities..
- Youth Members: 8-18 years of age, split into three distinct groups:
  - o Junior: 8 10 years of age
  - o Intermediate: 11 to 13 years of age
  - o Senior: 14 to 18 years of age

#### **Scholarship Opportunities**

During Thanksgiving and Christmas break, now is the time to start on your scholarships. Past Record Books or Permanent Record Books will give you ideas on what club offices you held, community service performed, awards won, etc to help complete your scholarship applications. Washington State 4-H is pleased to offer a number of different scholarships. Currently enrolled Washington State 4-H members are eligible to apply. Applicants must have accumulated at least two years of 4-H affiliation. Previous Washington State 4-H scholarship recipients are not eligible to apply. Applicant must be a high school senior attending an accredited two or four-year college or university in the fall.

Washington State 4-H Scholarship Applications MUST BE COMPLETE, with submission of all five pieces included, in order be considered. Each applicant will be considered for all Washington State 4-H Scholarships. The application must be submitted by March 15 no later than 9:59 PM. These scholarships may be used at any accredited two or four-year college or university.

- Woody and Joan Bernard 4-H Scholarship \$1,000 scholarship you must plan to attend a four-year accredited educational institution or two-year vocational institution.
- Lewis County 4-H Leaders Scholarships (Two @ \$1,000, One @ \$500) you must plan to attend a two or four- year college. Applicants can be from any county in Washington State.
- O.M. Plummer Memorial Scholarship \$500 scholarship you must be attending a two or four-year college.
- Thomas R. Quann Scholarship \$1,000 scholarship you must be a current 4-H member and plan to attend a two or four-year college.
- Washington State 4-H Foundation Trustees
   Scholarship \$1,000 scholarship you must be a high school senior and attend a two or four-year college.
- WSU CAHNRS 4-H Scholarship \$3,000 and \$1,500 scholarships available you must have been a 4-H Club member for a least two years, a leader among your peers, and plan to attend the College of Agricultural, Human, and Natural Resource Sciences at Washington State University your freshman year.
- J. Orville/Helen Young Memorial Scholarship to be considered for this \$500 scholarship you must be a current 4-H member and plan to attend a two or four-year college.

The Washington State 4-H Dairy Endowment also offers two \$500 scholarships. The Washington State Dairy Endowment Scholarship requires a separate application from those above and is due April 1st. The Dairy Endowment offers scholarships to present or former 4-H Dairy Project members – one for a high school senior and one for a current college student. #### **ANIMAL OWNERSHIP TIMELINES**

4-H members need to be completely enrolled (forms completed, signed and turned in to the Extension office, their Club Assessment fee paid) and their animals must be under the 4-H member's regular care and management for the following periods of time prior to the official county exhibit activity, including junior livestock shows:

Rabbits and Poultry -45 days Cavies -45 days Dogs -60 days Cats -60 days Goat -60 days Llama -90 days Sheep and Swine (Breeding & Market) -60 days (Swine see Rule 5C for CWJLS)

Equine – 90 days (Make sure your horse certificate is on file 90 days before first show/event)

Dairy–90 days, Dairy Heifer Replacement– 60 days, (Make sure your dairy certificate is on file 90 or 60 days before first show/event

Market Beef - 120 days, Breeding Beef - 90 days Animals raised by the 4-H member from birth or hatching are exempt from the minimum time periods

## **NEWS YOU CAN USE**

#### YAKAMA CARES

Yakama Nation Legends Casino Hotel and its team members understand the importance of being good citizens to the Community and that this is paramount for good business. We give two percent (2%) of our Class III Table Games Revenue to a Community Impact Fund. Funds are then distributed once a year by a Community Impact Fund Committee. This committee is made up of five local community government representatives. These funds have made it possible to purchase fire trucks, ambulances and police vehicles. They have also provided funds for road improvements and other community projects.

Legends Casino Hotel also has other payments for impact costs, community impacts, and charitable donations from 1% of the CIII gaming revenue machines. One half of the 1% is for charitable donations and the other half of the 1% covers the impact costs and tribal community impacts.

Applications for the non-Tribal non-profit organization can be submitted yearly to the Charitable Fund Committee from January 1 through March 31, and these funds will be distributed in May of each year. Applications need to be made in a letter format stating:

- 1. Name of Organization
- 2. What this Organization does
- 3. How much money the Organization is seeking
- 4. How this money will be utilized (spent)
- 5. A copy of a Certified Washington State Non-profit Status Form (This must be submitted with the written request. If this Non-profit Status Form is not attached, your organization's request will not be considered for funding.) 2023 application available soon.
