Motion carried. The monetary funds from the disbanded club total \$1,334.37. Lynda made a motion to split the funds equally between the 2 new Do. Co. dog clubs. Julia 2nd. Motion carried.

New Business:

Record Book Scoring: A discussion was held on the minimum score to go to County. Lynda moved to change it to 80. Deb 2nd. Motion carries. Polly moved to have the county awards be based on 80 or above. Deb 2nd. Motion carried.

Money in clubs: Michelle presented an example of what the money trail needs to look like. The steps that need to take place were on the board for discussion. Michelle is going to type them up for us and e-mail out for everyone to follow.

Rabbit Show: June 1st ARBA show to be held at NCW Fairgrounds. Lots of showing and classes will held.

Next meeting date is January 8th at 6:00 to be held at the Chelan County Extension Office.
