

Chelan County Leaders' Council Minutes
March 1, 2010

The March 1, 2010 meeting of the Chelan County Leaders' Council was called to order at 7:09 by President Thera.

Introductions were made.

Minutes: Linda made a motion to approve the January 11, 2010 minutes. The motion was seconded and approved.

Treasurer's Report: Cindy reported that there is \$3,127.70 in checking and \$2,079.70 in the CD. The CD will be due in April. Cindy paid insurance of \$466.00 to American Life Insurance Company. Thera made a motion to approve the treasurer's report. The motion was seconded and approved.

Old Business:

Jessica Zimmerman, a recipient of a 2009 scholarship, reported that she used her scholarship to help pay for a chemistry class she was enrolled in at Wenatchee Valley Community College. She thanked everyone for their support.

Committee Reports:

Horse - Linda clarified qualifications for participating in the NCW Fair. Chelan and Douglas County 4H members must attend at least 2 shows. The shows may be bi county 4H shows or open shows. If a member attends only 1 show, he/she can attend horse camp and still meet the qualifications.

Linda reported that it is not acceptable to cross ages in round robin. Therefore, at the end of the year, results from the bi county show series will determine the buckle winner. At the Chelan County Fair it is necessary to designate a changing room because the public needs to see the tack. Partial coverage of the tack room is acceptable. A herdsmanship chart will be created for the Chelan County Fair. Chelan County Fair may go to having an open show with 4H

classes within it to help offset empty stalls. It was asked who our representative is at the fair board meetings. There is going to look into it.

Dates are penciled in for horse camp. However, the dates need to be approved by Appleatchee. The dates are June 22-24. The bi county horse series' pamphlet is completed and will be posted online. It was asked if leaders should be responsible for getting pamphlets to members. Leaders should print pamphlets for members, but it is ultimately the responsibility of members' parents to personally get the information.
