

## **Chelan County Fair Online Market Sale:**

### **Registration:**

- 1.) Each exhibitor is allowed to sell one market animal in the online market animal sale.
- 2.) Exhibitor must have shown animal in the virtual show to be able to sell at the auction.
- 3.) Exhibitors are to use the honor system to declare their market animal meets the weight requirements for the Chelan County Fair. Weight requirements for livestock can be found in the Chelan County Fair Book.
- 4.) Exhibitors must register for the sale by August 7<sup>th</sup>, 2020. Registrations can be completed by completing the registration form and submitting to the Chelan County Fair Office.
- 5.) Quality Assurance Market Health Records for all species and brand slips for beef are to be provided at time of animal drop off.
- 6.) An email with your animal's tag number, your full name and your chapter/club in the subject line. In addition, in the body of the email, a description/bio of your project and approximate animal weight to be used in your lot of the auction is to be provided by September 1<sup>st</sup>, 2020.
- 7.) Pictures of your project will be used from exhibitor's pictures submitted for the virtual show.

### **Virtual Auction**

- 1.) Auction will be conducted by Chelan County Fair, Best Bid Auctions, LLC and Virginia Feeders, LLC.
- 2.) Auction will start the Monday following the virtual show and conclude that Thursday evening.
- 3.) Sale order will be determined by the placing of the virtual show. Tag number order will be substituted for sale order outside of virtual show placings.
- 4.) Sale will happen at [bestbidonlineauctions.com](http://bestbidonlineauctions.com)
- 5.) Animals will sell by the head, not the pound.
- 6.) Exhibitors pictures, name, 4-H Club/FFA Chapter, approximate animal weight and project bio will be viewable by bidders over the course of the auction.
- 7.) Exhibitors are strongly encouraged to reach out to potential buyers to instruct them on the online auction this year. All previous bidders at the Chelan County Fair will be notified of the online auction format.
- 8.) 3% will be deducted from the exhibitor's sale amount to cover administrative costs associated with conducting the auction.

### **Drop Off Procedure:**

- 1.) Animals will be dropped off the Saturday immediately following the auction between the times of 9:00 AM and 6:30 PM. Animals must be dropped off Saturday, no exceptions.**
- 2.) Animals will be weighed as they are unloaded.**
- 3.) Only essential people are asked to come to unload animals.**
- 4.) You will need to remain in your vehicle until it is time for you to unload.**
- 5.) Fair and auction company personnel will handle moving your animals to holding pens.**
- 6.) Buyers, Packers, and Custom Meat Companies will arrive Sunday morning to pick up animals from the fairgrounds.**
  - a. Buyers will designate at time of purchase their arrangements for the animal they have purchased.**
  - b. If the purchaser of the animal and the seller know each other and arrangements have been made between you and them for post-sale please have them notify us at [chelancountyonlinemarketsale@gmail.com](mailto:chelancountyonlinemarketsale@gmail.com) there is no reason to bring to the fairgrounds if you have made other arrangements.**
- 7.) No animal is to remain on the fairgrounds after the Sunday immediately following the auction.**
