

**INTERAGENCY AGREEMENT  
BETWEEN  
THE WASHINGTON STATE  
COMMISSION ON HISPANIC AFFAIRS  
AND  
WASHINGTON STATE UNIVERSITY**

**PARTIES TO THE AGREEMENT**

This Interagency Agreement is made and entered into by and between the Washington State Commission on Hispanic Affairs, hereinafter referred to as "CHA", and the Washington State University, hereinafter referred to as "WSU", pursuant to the authority granted by Chapter 39.34 RCW.

**PURPOSE**

The purpose of this Agreement is to provide funding to CHA for sponsorship of a radio program "*Conozca su Gobierno con Uriel Iniguez*," broadcast Tuesdays and Thursdays on KNTS Radio Luz 1680 AM and KTBK Juan 1210 AM, including simultaneous airing on Radio KDNA 91.9 FM, KCED Centralia 91.3 FM, and KSVR 91.7 FM. It is a twelve month live radio program which consists of weekly one hour on-air segments between the hours of 10AM and 11AM every Tuesday and Thursday.

**PERIOD OF PERFORMANCE**

This Agreement shall become effective on **July 5<sup>th</sup>, 2011** and will expire on **June 28<sup>th</sup>, 2012**, unless terminated sooner or extended as provided herein.

**STATEMENT OF WORK**

CHA shall provide 16 30-minute segments of the program airing on KNTS, KTBK, KDNA, KCED and KSVR to discuss topics selected by WSU. WSU will have the opportunity to present information on various topics on a rotational basis to the Spanish speaking population of western Washington including parts of eastern Washington. WSU is responsible for furnishing material in Spanish and a Spanish speaking agency representative who will provide the information in Spanish to the radio listening audience. If either party must cancel a scheduled segment at the last minute due to unforeseen circumstances, WSU shall have the opportunity to reschedule the segment at no additional cost.

**COMPENSATION**

WSU shall pay CHA an amount not to exceed **three thousand dollars (\$3000)** for the performance of all things necessary for, or incidental to, the work as set forth in the Statement of Work of this Agreement.

Upon execution of this Agreement, one request for payment under this Agreement shall be submitted. Upon receipt and approval of the properly executed invoice, WSU will remit payment to CHA in a total amount not to exceed the value of this Agreement.

**MANAGEMENT**

The Program Manager for each of the parties shall be responsible for and shall be the contact person for all communications and billings regarding the performance of this Agreement.

**DISPUTES**

Disputes arising under this Agreement shall be resolved by a panel consisting of one representative from CHA, one representative from WSU, and a mutually agreed upon third party. The dispute panel shall thereafter decide the dispute with the majority prevailing.

**TERMINATION**

Either party may terminate this Agreement upon ten (10) days written notice to the other party. In the event of termination of this Agreement, the terminating party shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.


**AGREEMENT CHANGES, MODIFICATIONS AND AMENDMENTS**
