PLO: Phytoplasma such as Witches broom, Haywire, Purple Top, BLTVA
VM, OT, OV: Variety Mix, Off-Type, Off-Type Variety

Comments:

Variety, seed grower, and source (state) is provided solely by the seed receiver. We transfer that information to this book and save the original tags. Please contact Mark Pavek with any concerns or changes.

There should be a plant every 10-12 inches. Exceptions: top of bottom of lot where planter ran out of seed, seed tubers too large for planter, or plant did not emerge. You may dig for seed pieces.

Lots are 2 rows wide each by 100 feet in length (200 ft total)

Plants were VISUALLY read, unless otherwise indicated. PVY test kits are used often.

MOSAIC does not necessarily mean the plant has PVY; rather, it is expressing symptoms that are commonly associated with PVY infection. It is likely, however, that those plants flagged with mosaic flags are infected with PVY. Moreover, PVY was confirmed in some flagged plants via an in-field test kit. PVS may be flagged as Mosaic.

NOTE: ALL PLANTS expressing visible symptoms were flagged (in the past, we never flagged more than 10 infected plants; the seed lot was recorded as having “Many”).
