MINUTES Board of Regents July 12, 2017

The Board of Regents of Washington State University (WSU) held a special meeting pursuant to call in Open Meeting at 9:00 a.m., on Wednesday, July 12, 2017. The meeting was held on the WSU Pullman campus in Lighty Student Services Building, Room 401.

- I. Call to Order. Regent Ted Baseler, Chair called the special meeting to order. He welcomed everyone to the meeting and said the purpose of the meeting was consider tuition rates for the academic year 2017-2018. III. Action Item 1: Academic Year 2017-2018 Tuition Rates.

tuition rates as outlined below for the academic year 2017-2018, as the legislature has concluded its session regarding the operating

budget.

SUPPORTING INFORMATION:

State law authorizes the governing boards of the four-year higher education institutions to establish tuition and fees for all student categories except resident undergraduates. Although tuition-setting authority for resident undergraduate tuition was granted in the 2013-2015 biennium, the legislature reduced tuition for resident undergraduates in the 2015-17 biennial budget. The decrease in 2016 was 5%; the 2017 decrease was an additional 10%. The legislature also provided backfill funding for these tuition decreases. For the 2017-2019 biennial budget, the legislature did not freeze or further reduce resident undergraduate rates. Current law allows an increase in the resident, undergraduate tuition rate of 2.2% for FY18.

Most tuition rates for academic year 2017-2018 will remain the same, with the following exceptions, which were approved in May, 2017:

- 1. An increase in tuition rates for the Online MBA program and the Online Executive MBA.
- 2. An increase in tuition rates for Veterinary Medicine effective fall 2017.
- 3. A new rate for the Professional Science Masters, Electrical Power Engineering.
- 4. A new rate for the Elson S. Floyd College of Medicine.

The proposed 2017-2018 tuition rates, along with the existing 2016-2017 tuition rates are shown below as full-time, annual rates for reference.
