Weekly Write-ups – following each speaker, students will develop an abstract (250-500 words) that synthesizes the paper and discussion that week. 50% of grade. Assignments will be accepted up to 1 day late for half credit.

Monthly Write-ups – students will develop a short communication (1000-2000 words) that synthesizes the previous topics and develops a study or intervention to improve health and safety for pregnant workers. 50% of grade. Assignments will be accepted up to 2 days late for half credit.
