1. Credit Hours: 15 credit hours total
2. Required Course
 - a. ED PSYCH 505 or ED RES 563
3. Selective Courses: Complete one PAIR of courses
 - a. ED PSYCH 508 and ~~ED PSYCH 565~~ ED RES 565
 - b. ~~ED PSYCH 536 and ED PSYCH 564~~ ED PSYCH 507 and ED RES 564
4. Electives: 3 credits minimum
 - a. ~~ED RES 567, ED RES 568, ED RES 570~~, CSSTE 544, CSSTE 545, T&L 588, SPED 592, ED PSYCH 509, ED PSYCH 568, ED PSYCH 569, ED PSYCH 570, ED PSYCH 572
5. Applied Project: 3 credits minimum
