SUBJECT: Proposal to Revise Rule 90f

At its meeting on February 25, 2020, AAC approved a proposal to revise Rule 90f, with defines the different variations of "Satisfactory" grading.

One of these grade types has been A, S, F grade which was established only for use with PE_ACTIV courses. The PE_ACTIV courses have now been moved to the Department of Kinesiology and Educational Psychology under new prefix KIN_ACTIV. The department has requested that these courses be offered for S, F grading.

Consequently, the reference to the A, S, F grade below should be deleted from the rule. In addition, the rule has been revised to reflect the S, U grading basis and for overall clarity.

90. GRADES AND GRADE POINTS

...

90f. S. (Satisfactory.) Grade given upon satisfactory completion of courses approved for one of the following grading basis, which are designated in the catalog and schedule of classes and are used for both final and midterm grading.

S, F (satisfactory, failing) grades are used to report grades for courses numbered 499, 600, 700, 701, 702, 800, special examinations (Rule 15), and other courses duly authorized for S, F grading by the Faculty Senate. (Courses approved for S, F grading are footnoted in the Schedules of Classes.) Courses approved for S, F grading may also be graded S at midsemester indicating satisfactory progress.

~~_____ A, S, or F grades only are used to report physical education activity grades.~~

_____ S, U (satisfactory, unsatisfactory) grades are used to report grades only for courses numbered 700, 701, 702, and 800.

S, M (marginally satisfactory), or F grades only S, M, F (satisfactory, marginally satisfactory, failing) grades are used to report grades only for designated courses within the College of Veterinary Medicine.

H (honors), S, or F grades only H, S, F (honors, satisfactory, failing) grades are used to report grades only for designated courses within the College of Medicine and the College of Pharmacy.

90f. S. (Satisfactory.) Grade given upon satisfactory completion of courses approved to be taught with one of the following grading basis, which are designated in the catalog and schedule of classes and are used for both final and midterm grading.

S, F (satisfactory, failing) grades are used to report grades for courses numbered 499, 600, special examinations (Rule 15), and other courses duly authorized for S, F grading by the Faculty Senate.

S, U (satisfactory, unsatisfactory) grades are used to report grades only for courses numbered 700, 701, 702, and 800.

S, M, F (satisfactory, marginally satisfactory, failing) grades are used to report grades only for designated courses within the College of Veterinary Medicine.

H, S, F (honors, satisfactory, failing) grades are used to report grades only for designated courses within the College of Medicine and the College of Pharmacy.

At this time, Faculty Senate review and approval is recommended, to be effective fall 2020.
