JUSTIFICATION FOR DROPPING THE GRADUATE CERTIFICATE IN CONSTRUCTION MANAGEMENT.

At the Engineering and technology Management Faculty meeting, October 17, 2019, it was proposed and approved the the graduate certificate in Construction Project Management be canceled.

When the certificate was placed in our list of available graduate certificates, it was believed that there was a need for a certificate that addressed both project management and construction management. Up to this point in time, only two recent students have completed the certificate and a mere seven previously since the certificate was first approved. This indicates that the demand is not strong enough to retain it in our available certificates.

We request that the Engineering and Technology Management Certificate in Construction Management be dropped from the WSU list of available certificates effective Fall 2020.
