



I am delighted to write this letter in support of a newly proposed college level research center in Special Education, the **WSU Research, and Innovation in Special Education**.

The College of Education has made significant personnel and resource investments to improve and expand research and scholarship related to special education. This is an important and growing area of research and scholarship nationally and aligns directly with WSU's mission as a land grant institution as the work will help improve the lives of individuals with disabilities, and their families and communities. Since 2015, our special education program faculty have received several millions of dollars in extramural funding for more than 23 scholarly grants or contracts related to research and innovation in special education. More recently, the College started the WSU ROAR program, which has become nationally known and is attracting both federal and private funding. Faculty in special education continue to be active in seeking additional federal and state funding opportunities to advance their work. To date, program faculty have worked organically with college and departmental support. Hello Pablo, Jeb and Karen,

Greetings from myself and two colleagues within the College of Education who are supporting the advancement of a Special Education focused Research Center here at WSU (Proposed Assistant Director Dr. Don McMahon; and COE Associate Dean for Research Dr. Olusola Adesope). We are grateful for your review of our application and questions and comments in the Fall. We apologize for our delayed response as we've had to prioritize our current research, teaching and service activities. Despite our delays, our desire to move forward with establishing a Special Education Research Center has not waned!

In your November review you raised some important feedback and comments that we have addressed in our revised CICU application. The attached document(s) show the text we originally submitted on the CICU application form, with track changes to show how we addressed your comments. We have also provided a written response to each of our comments below:

- Feedback from RAC Chair and Co-Chair: Name must include either Center or Institute
  - **Our Response:** We have updated the proposed name in our CICU Application to: "WSU Center for Research and Innovation in Special Education".
- Feedback from RAC Chair and Co-Chair: Please specify which metrics we plan to measure, as not all of the metrics are relevant to every center.
  - **Our Response:** Thank you for this clarification. We have updated our CICU Application to minimize the number of metrics that we will measure and report out on. The metrics that we have chosen are those that we believe our most aligned with the overall goals and objectives of the proposed center, and can be used both formatively and summative to monitor and advance our work.
- Feedback during Stakeholder Comment Period: "It is confusing to have WSU at the top of the org chart, as this implies it is a university level center. The application indicates the College of Education oversees the proposed center. Please clarify."
  - **Our Response:** To address this comment and clarify the College of Education will oversee the proposed College level center, we have removed "Washington State University" from the top level of the proposed organizational chart. However, if in the

next steps of the review it's determined we should add back in the natural hierarchy of the University, we would be happy to revert to our previous version with WSU as the parent organization to the College of Education.

- Feedback during Stakeholder Comment Period: "No members are listed outside of Special Education, yet the external funding examples include faculty outside of Special Education and the applications states it works across disciplines. Please clarify why such faculty are not members or affiliates given the current work."
  - **Our Response:** Thank you for this comment. We had been waiting until the center was proposed before soliciting partner involvement. However, we have reached out to two of our regular collaborators (Dr. Jonah Firestone, Science Education; Dr. Kira Carbonneau, Educational Psychology) to confirm their role as "Center Affiliate" if the proposed center is approved. The number of interdisciplinary partners is likely to increase once the Center is approved.
- Feedback during Stakeholder Comment Period: "The proposed center is said to be primarily research. However, in the description and in the funding (TPSID funding), there is a strong focus on service. Please clarify if this is a primarily research or balancing service and research. That latter seems to be the case."
  - Our Response: Thank you for this comment. Despite the service our faculty engage in, we would like to establish our proposed center as a Research Center focused primarily on Research. Affecting positive change in special education involves interventions that improve the lives of students with disabilities and creating new knowledge and research based on those efforts. This work, and the contracts that help support this work, could be perceived as service; however, with this work we engage in research and scholarship. The innovative work that that we do directly for students with disabilities is designed to test the impact of evidence-based practices and to help develop new models of instruction and strategies to support individuals with disabilities. The special education faculty have a strong track record of capitalizing on this cycle of innovation, research, and dissemination. The WSU Center for Research and Innovation in Special Education will increase these capabilities.

Thank you again for your initial review of our CICU, and your consideration of our proposed responses to your comments. We are grateful that you are excited to move forward with our registration as an official WSU Center, and are also excited about the ways this will further support our work advancing the mission and goals of WSU. We sincerely believe this is to everyone's gain, including students with disabilities and the services and systems that support their educational and life outcomes.

Dear Dr. Poppen,

I am a co-chair for the Research and Arts Committee (RAC) with Dr. Jeb Owen (CC'd). We have received your registration for a new Center/Institute at WSU and would like to address a few questions and comments before we move forward.

Firstly, we now ask that each Center or institute incudes either "center" or "institute" in the name of their unit to help distinguish between official center/institutes and other groups on campus. (WSU *Center for* Research and Innovation in Special Education, for example).

Second, we are unclear which metrics you will be measuring. In your registration form, it appears the list of suggested metrics from the policy and procedures handbook was simply pasted into your registration form, with some of the bullets appearing as question marks. We ask that you specify which of these metrics (or others) you plan to measure, as not all of the metrics we suggest in the P&P are relevant to every center, and we do not require each center to report on every one of those metrics, only the ones that directly pertain to the goals of the individual center.

Third, during the stakeholder comment period, we received some feedback from another center director who had some questions, and we'd like to give you the opportunity to address these:

- 1. "It is confusing to have WSU at the top of the org chart, as this implies it is a university level center. The application indicates the College of Education oversees the proposed center. Please clarify."
- 2. "No members are listed outside of Special Education, yet the external funding examples include faculty outside of Special Education and the applications states it works across disciplines. Please clarify why such faculty are not members or affiliates given the current work."
- 3. "The proposed center is said to be primarily research. However, in the description and in the funding (TPSID funding), there is a strong focus on service. Please clarify if this is a primarily research or balancing service and research. That latter seems to be the case."
