Course Objectives

Upon successful completion of this course the nurse will:

- Locate for review the most current Laws as they relate to nursing practice in the State of Washington.
- Define the difference between RCW's and WAC's in the Washington State Law.
- Describe the requirements in the State of Washington that must be met to be permitted to practice as a Licensed Practical Nurse.
- Describe the qualifications of the members of the Nursing Care Quality Assurance Commission in Washington.
- Identify professional groups regulated by the Uniform Disciplinary Act of Washington.
- Identify violations of the Uniform Disciplinary Act that would require intervention by the State Nursing Care Quality Assurance Commission.
- Apply the Scope of Practice, defined in the Washington Administrative Code, to the role of the Licensed Practical Nurse in different health care environments.
- Differentiate between a dependent and an independent role of the Licensed Practical Nurse.

Successful Course Completion

Questions outlined in the study guide must be completed and each multiple-choice question must be answered. Each completion question (10) and each multiple-choice question (10) will be valued by 4% of the total 100% score. Course participants must achieve a score of >73% for successful completion of the course.

Upon successful completion of the course a certificate of completion will be issued to the participant. The Washington Nursing Commission will be notified and the participant will receive a copy of the certificate, copy of the email notification of the nursing commission and a fax transmission notice that the commission has received a faxed copy of the certificate.
