### 1. Andrew J. Cassey

School of Economic Sciences

Leave Period Requested: August 16, 2015 - May 15, 2016

Purpose of Leave: Focus will be on conducting research on how exported goods at the state level are related to informational barriers to trade facing exporters. Will be visiting Penn State University, the University of Minnesota and the Federal Reserve Bank in Minneapolis.

**Biological Systems Engineering** 

Leave Period Requested: July 1 - December 31, 2015

Purpose of Leave: To learn molecular modeling and new fuel characterization and combustion techniques at the Chemical Engineering Department at the University of Houston.

### 3. Jessica R. Goldberger

Crop and Soil Sciences

Leave Period Requested: January 1 - May 15, 2016

Purpose of Leave: Qualitative research will be conducted to understand the factors driving transitions to sustainable pest management practices in New Zealand apple orchards. Enhance repertoire of assessment/treatment tools for instruction of WSU students. Locations are Virginia Tech, UC Davis, University of British Columbia.

Leave Period Requested: August 16, 2015 - May 15, 2016

Purpose of Leave: Undertake intensive preliminary research for a six-volume critical edition of the first English translation of Montaigne's "Essays" (London, 1603). This edition will be published by Oxford University Press. Will collaborate with scholars based in the USA and UK and primary locations are London, Paris and Cassis.

Purpose of Leave: Travel to Japan to complete four chapters for a book on hunter-gatherer social learning. Travel to Ethiopia to conduct research and write a grant. Begin a new book on evolutionary cultural anthropology.

### 17. Christine Horne

Sociology

Leave Period Requested: August 16, 2015 - May 15, 2016

Purpose of Leave: Research will focus on social factors and processes that affect the resilience of the US electricity and telecommunications systems. Identify system-level features that contribute to vulnerability, social features that have implications for actors' ability to coordinator/cooperate to address vulnerability, perceptions and strategies of system actors, and the distribution of costs associate with failure of the systems. Date will be collected primarily from Washington State actors, with supplemental data from national sources.

Purpose of Leave: To Write a vibraphone "omnibook" (method book of transcribed solos) to be used as a teaching text in college percussion studios. Method book will consist of a collection of solos accompanied by harmonic and melodic analysis of three jazz vibraphonists: Lionel Hampton, Red Norvo and Milt Jackson.

Purpose of Leave: Push research on plant-driven chemical weathering into a new phase of application to managed ecosystems, and to work collaboratively on plans to monitor the effects of these processes on agricultural sustainability across the nation's new network of Long-Term Agroecological Reserves.

Proposal collaborations will lead to submission of NSF and NIH grant proposals, as well as peer-reviewed publications.
